

Utilizing private sector involvement at the local level through Public-Private Partnerships (PPPs) to enhance the delivery of sustainable water and sanitation services in Asia Virtual workshop (via Zoom)

Summary:

Access to clean water and safe sanitation is one of the most critical infrastructure issues in the world, with a significant impact on public health. In many developing countries, the water and sanitation infrastructure are inadequate due to various hurdles, including the lack of technical capacity and insufficient financing. As discussed in Policy Brief No. 2023-3 – Long-Term Financing for City-Wide Inclusive Sanitation, innovative and long-term financing options are needed to fund the sizeable capital investments required to address the infrastructure gap. The public-private partnership model, used by governments across the world, which brings together the public and private parties for the development and operation of various categories of infrastructure is one of the models that stands out as one of the potential tools to mobilize to address the infrastructure gap in water and sanitation infrastructure in developing countries.

Led by Prof. Yu Namba of Toyo University Graduate School of Public-Private Partnership, this half-day online workshop for government officials and practitioners from developing member countries (DMCs) of ADB will delve into the fundamentals of the public-private-partnership ("PPP") model, the use of the model by the local governments as the parties which generally assume the primary responsibility for water and sanitation infrastructure and issues and opportunities specific to the use of the PPP model in the context of relevant infrastructure. Final session of this workshop will focus on the use of the PPP model in the Asian countries to develop and/or improve the water & sanitation infrastructure. The sessions will include interactive Q&A discussions.
