RCI and ADB Strategy 2030



RCI is one of the 7 Operational Priority Areas under Strategy 2030.

- Historic area of comparative advantage for ADB
 - Mandate and roles
 - Subregional groupings
- Unique transboundary opportunities and challenges
 - Address positive spillovers and negative externalities
 - Impact key economic sectors and thematic areas
- Cooperation among DMCs
 - Mechanisms for addressing transboundary issues
 - Stronger collective voice in global trade, investment, and environment/climate frameworks



RCI trends and challenges



Infrastructure connectivity

Attention to quality subsector integration, software focus, and new technology for efficiency, and productivity of physical infrastructure connectivity
Need 'Green' infrastructure (less energy-intensive and less natural resourceintensive)

Financial sector

- •More interconnected but still too bank dominated
- •Requires partnerships to support cross-border financial flows
- •Requires policy and regulations for data flows and to protect against risks

Trade and investment

- •Requires effective regional building blocks to underpin the multilateral trade system
- •More countries, business segments and sectors to participate in the trade and investment flows and global value chains



RCI trends and challenges



Inequality

 Need to reduce the risk of widening of spatial and skills premium inequality from global and regional trade and FDI

Climate Change

- Economic growth, population changes and urbanization are creating green house gas emissions, natural resource consumption and pollution and related health risks for the region
- Regional action is needed to complement national efforts




- 3-year average lending volume for 2016–2018 at \$4.5 billion
- RCI lending peaked in 2017 at \$5.5 billion






- TRANSPORT and ENERGY still comprised the bulk of RCI projects but year-on-year shares show a declining trend in these sectors.
- Support for more nascent sectors in RCI operations is expanding.
- Central and West Asia received the largest share of RCI funding.


Future RCI Operational Focus Areas

- Environmental protection and sustainable management of shared natural resources



RCI Business Opportunities



Area	Examples
Procurement	Connectivity infrastructure Economic corridor projects
Consultancy services	Sector-based economic analysis and project preparation/design
Technical Assistance	Business research skills, RCI economics, financial sector integration
Nonsovereign projects across borders	Agricultural value chains, logistics systems, digital technologies at border crossing points, virtual trade

RCI Issues for Consideration



- Maintain strong support for RCI in the ADB portfolio
- Achieve greater diversity in the RCI portfolio by sector and subsector
- Increase non-sovereign and PPP projects (e.g. Agricultural Value Chain Development Project)
- Support inter-subregional RCI operations



Example – PRC IMAR RCI Promotion



- Support PRC-MON cooperation under CAREC
- Total cost \$840 mn, ADB loan \$420 mn
- Multisectoral and cross-thematic approach
- Key outputs
 - Cross-border connectivity (BCP/BEZ roads, quarantine/inspection facilities for agri/animal trade, logistics, trade exhibition centers, etc)
 - Environmental and medical services in border towns
 - SME development (FIL, BDS, pilot of BDS support for female entrepreneurs)
- Varieties of consulting services needed
