<u>Updates to ADB's Procurement Directive – Key Changes</u>

ADB announced that beginning 1 January 2026, all internationally advertised contracts financed by the Bank will be evaluated using merit point criteria (MPC). This landmark reform is part of a procurement approach that strengthens ADB's commitment to quality, sustainability, and value for money in its projects, while also introducing broader changes to create more local jobs and increase early engagement with suppliers across Asia and the Pacific.

Korea's Procurement Policy and e-Procurement System

Under Korea's central procurement framework, the primary aim of domestic procurement is to ensure that government needs are met efficiently and cost-effectively, while enabling government agencies to perform effectively through timely supply of quality goods and services. The scale of Korea's public procurement, which annually amounts to billions of dollars, provides significant opportunities for implementing national policies. Korea's Procurement Policy emphasizes transparency, efficiency, and socio-economic impact, while the e-Procurement System (KONEPS) has been established to streamline procurement processes, improve accessibility, and enhance monitoring and accountability across government agencies.
