Virtual Workshop: ADB and the Green Climate Fund

ADB projects co-financed by the Green Climate Fund (GCF) introduce climate-smart innovations with transformational impact beyond the projects themselves, are scalable and replicable, and align with the climate change priorities of the beneficiary countries. They are designed to help ADB's DMCs move away from business-as-usual development to more sustainable pathways that are low-carbon and climate-resilient. This virtual workshop will provide an opportunity for staff to learn about strengthening the climate rationale for potential projects and GCF funding approval processes.

Virtual Brown Bag: Exploring the impact of the COVID-19 pandemic on global emission projections

Panel and Group Discussion: A Just Transition to a Low-Carbon and Climate-Resilient Asia and the Pacific

The Paris Agreement on climate change commits Parties to "taking into account the imperatives of a **just transition** of the workforce and the creation of decent work and quality jobs in accordance with nationally defined development priorities." The transition to a low-carbon and climate-resilient future will require radical restructuring. Just Transition recognizes the impact of such a transition on people and provides a bridge to a future where all jobs are green and decent, poverty is eradicated, and communities are thriving and resilient. This session will explore Just Transition planning and implementation; opportunities for ADB; and share joint MDB efforts on development of a common framework for Just Transition interventions.
