Digital COVID-Credentials has proven to be an effective tool for countries to restart mobility for work and travel. Such credentials have aided policymakers in negating the risk of COVID-19 spread, by virtue of clearly ascertaining the vaccination or testing status, in a fast and automated way rather than through laborious manual inspections.

Looking beyond COVID, the experience from various digital COVID-credential implementations around the world have demonstrated how digitally signed and offline-verifiable credentialing tools are a great lever to accelerate the long-pending push for wider “health data-personalization” and “enhanced trust” in public health transactions. These are critical priorities that will encourage countries to transition towards an inclusive patient-centered health ecosystem, as well as strengthen the argument for trust-based data-sharing, to foster continuity of care.
