About the Event

This knowledge symposium will present existing ADB projects and wider initiatives in the PRC's Yangtze and Yellow River basins to highlight key lessons learned and best practices for integrated river basin management.

The Asian Development Bank (ADB) has partnered with the People's Republic of China (PRC) to balance economic and social progress with environmental sustainability. ADB's role in supporting the PRC's Yangtze River Economic Belt (YREB) from source to sea has been pivotal. Adoption of a green ecological corridor and programmatic approach was a key innovation to coordinate public interventions for strengthening environmental management, ecological protection and inclusive economic growth. Based on the experiences from the YREB, ADB has designed a new program to promote high-quality green development in the Yellow River Ecological Corridor (YREC).

Such knowledge is important not only for the PRC but can also offer essential solutions to other developing member countries in Asia and the Pacific that are pursuing greener development pathways. The PRC's experience in designing innovative projects, introducing new policies, and strengthening institutional capacities can help offer models to address environmental challenges in the region. During a panel discussion, other ADB regional departments are also invited to showcase some of their river basin projects to share the lessons and challenges they have been facing.

Objectives

- Strengthen existing partnerships that add value to ADB's river basin programs and project operations.
- Build a wider network of reliable knowledge sharing partners (public & private sector) that can offer technical expertise and additional sources of financing.
- Share PRC's lessons learnt with a wider public and set a precedent for a regularly recurring event (e.g., annually), where ADB and external partners' case studies are shared and discussed and ways of collaboration beyond knowledge sharing are explored.
- Promote peer-to-peer learning within the Asia-Pacific region.

Audience

- Policy makers, water sector professionals, researchers, local and international NGOs working on river basin management in East Asia or in other regions.
- The audience will learn about river basin management approach, relevant novel laws, such as the Yangtze River Protection Law, innovative policies and hands-on experience from ADB operations in river basins across Asia.
- The aim is to connect practioners with one another and offer a starting point to the interested wider public for further engagement with approaches to river basin management.
