



**TA 6767-REG: Supporting Enhanced COVID-19 Vaccination and  
Post-COVID-19 Health Security Response in Southeast Asia (SECURE)  
Dissemination Workshop: From Evidence to Investment**

**May 26, 2026, 2:00-5:00 pm

## I. Rationale and context

As Southeast Asia transitions from emergency pandemic response to long-term health resilience the need for standardized, evidence-based policy has become paramount. ADB Technical Assistance (TA) SECURE (TA 6767-REG) has served as a primary knowledge engine for this transition in Cambodia, Lao PDR, Indonesia, the Philippines, Thailand, Timor-Leste, and Viet Nam. The TA has finalized a robust knowledge base comprising a flagship regional book, 28 technical webinars and 12 targeted policy and project briefs. This workshop marks the formal 'Knowledge Handover' of this base, providing a technical reference for national governments and development partners.

## II. Objectives

The workshop aims to:

- Disseminate the SECURE Book and the DevAsia knowledge repository as policy and operational instruments.
- Present technical briefings on climate-smart hospital infrastructure (Thailand), medical sovereignty/vaccine manufacturing readiness (Viet Nam) and regulatory and pharmacovigilance (Timor-Leste).
- Demonstrate how national governments and development partners can utilize SECURE TA knowledge products:
  - HRH Development: 28-webinar repository as a structured training and continuing education tool for health professionals.
  - Policy reform: adopt the project and policy briefs as technical baselines for national regulatory frameworks (e.g., Pharmacovigilance and Private Sector Engagement).
  - Project design: Integrate evidence from SECURE TA into the design of potential sovereign and non-sovereign health projects.
