Scaling What Works: Private Sector Development as Catalyst for Growth in Southeast Asia 18 November 2025 | 4:00 – 5:15 PM, MNL time

Mobilizing private sector capital is crucial to addressing the multitrillion-dollar financing gap for development in Asia and the Pacific, which public funds alone cannot cover. To help bridge this gap, the Asian Development Bank (ADB), through its Strategy 2030, has prioritized private sector development as a key institutional focus. Since 2022, ADB has more than doubled its nonsovereign operations and aims to achieve \$13 billion in annual private investment by 2030, including \$4.5 billion in direct private capital mobilization.

In Southeast Asia's dynamic markets, private capital is key to driving sustainable growth and strengthening economic resilience across sectors such as digital infrastructure, clean energy, transport, urban infrastructure, and resilient supply chains. Rapid economic growth, urbanization, and population increases in the region have created a substantial infrastructure financing shortfall. To meet growing demand and to stay on track with 2030 climate targets, ADB estimates ASEAN's annual investment needs range between \$184 billion and \$210 billion. With limited public financing available, scaling up sustainable investment will require innovative financial mechanisms beyond traditional commercial debt finance, underpinned by consistent regional collaboration and strong policy support.

This webinar will explore how ADB is translating its ambition into impact through real-world case studies that showcase how it is strengthening private sector development and capital mobilization across the ASEAN region.

Participants will gain practical insights into how ADB's lending, guarantees, transaction advisory services, and technical assistance have supported market development and policy reform. They will also learn how governments and project sponsors can leverage ADB's full private sector development toolkit, including upstream policy support, blended finance, and risk-mitigation solutions to advance their priority initiatives.

The webinar is organized by the Green Finance Hub (GFH) of ADB's Southeast Asia Regional Department (SERD) and the ASEAN Catalytic Green Finance Facility (ACGF) in collaboration with ADB's Private Sector Development. It is hosted by ADB's Southeast Asia Development Solutions (SEADS) platform.

GFH provides crosscutting support to ADB's developing member countries in Southeast Asia to accelerate green investments and advance innovative financing solutions in response to the region's climate, energy, and financing needs. Managed by GFH, ACGF is an ASEAN Infrastructure Fund initiative owned by ASEAN governments and ADB that helps Southeast Asian countries prepare and finance environmentally sustainable infrastructure projects contributing to climate and sustainability goals.
