**On Implementation of the Government Decree
of the Kyrgyz Republic of August 12, 1997 # 467
"On licensing of activity on production and sale of
chemicals (in agrochemical part)"**

In fulfilment of the Government Decree of the Kyrgyz Republic of August 12, 1997 # 467 "On licensing of activity on production and sale of chemicals (in agrochemical part)" I hereby

Order:

1. The heads of Directorates of the Ministry of Agriculture and Food, the head of Department of Chemical Supply and Plant Protection, its structural sub-divisions, the heads of oblast and rayon directorates (departments) of agriculture shall follow and execute this Decree of August 12, 1997 # 467.
2. The head of the Department of Chemical and Plant Protection (Mr. Puk V.A.) shall:
 - within a month submit proposals about establishment of the Republic Commission on testing and registration of chemical, biological plant control agents, pheromones and plant growth regulators of agricultural plants and forest plantations;
 - within a week prepare and submit to Custom's Inspectorate under the Government of Kyrgyz Republic a list of plant growth regulators allowed to use in the Kyrgyz Republic. Besides, the above-mentioned list shall be distributed to all oblasts and rayons, directorates (departments) of agriculture, dependent plant protection services;
 - identify business entities, physical and legal persons engaged in production, sale and application of chemical and biological plant control agents for seed and sown of agricultural crops and inform them in written about the necessity to receive a license before December 31, 1997;
 - conduct the explanatory work in mass-media (press, TV, radio) on issues of licensing of agrochemical activity;
 - before September 25, 1997 prepare and submit to the Government for consideration Draft Law "On Chemical Supply and Plant Protection in the Kyrgyz Republic";
 - to ask mass-media advertisement agencies not to advertise chemicals from advertisers and not to accept their advertisements with no licences on sale rights.
 - to organise training courses for physical and legal persons on self-supporting basis devoted to the rules of safety use, storage and application of chemicals and issue of corresponding certificate after courses;

- to set up expert commissions for certification of physical and legal persons and submission of documents required for registration and issue (prolongation) of licenses to the Department of Chemicals and Plant Protection in accordance to the Regulations "On licensing" in oblast plant protection stations.

3. To charge Deputy Minister, V.N. Berezin, with control over the execution of this decree.
