

To share knowledge and tools that can assist the public sector internal audit institutions in building and strengthening governance in their countries.





WHAT'S IN THE PIPELINE

CAPACITY DEVELOPMENT ASSESSMENTS

- Myanmar Central Bank of Myanmar needs assessment of internal audit function
- Cambodia ongoing coordination with Southeast Asia RD and Cambodia Resident Mission

WORKSHOPS

- Sri Lanka possible collaboration with South Asia RD
- Indonesia and Lao initial discussions with ADB resident missions

OTHERS:

- Malaysia Bank Negara Malaysia (CB) will send two internal audit staff for an attachment for two weeks in May 2017 to study Internal audit best practices in ADB
- Viet Nam indication of interest from Viet Nam International Bank Head of Audit (with State Bank of Viet Nam)
