# ADB Office of the Auditor General (OAG) Terms of Reference for the Panel of Experts to the OAG Capacity Development Working Group

#### **Overview**

- 1. The Capacity Development Working Group (CDWG) is a self-directed group in the Office of the Auditor General (OAG) created to provide advisory services to ADB management in:
  - Supporting internal audit capacity development in public institutions of developing member countries; and
  - Knowledge-sharing on internal audit processes and practices.

## **Purpose**

- 2. The Panel of Experts is an advisory board to provide independent, objective and expert advice to the CDWG on:
  - strategizing and identifying opportunities for internal audit capacity development in the public sector of ADB developing member countries;
  - developing and formulating capacity building and knowledge sharing frameworks for internal audit function in the public sector; and
  - supporting programs and initiatives in enhancing the professional practice of internal audit in member countries.

### Composition

- 3. The Panel of Experts comprise of up to five members<sup>1</sup> serving in personal capacities on the panel. Members of the Panel should have:
  - Extensive professional experience and specialist knowledge in the development of public sector internal audit activities.
  - Proven track record in successfully managing internal audit activities in public sector institutions, and/or private sector organizations.
  - Recognized leadership in and/or distinguished contributions to the field of internal audit.
- 4. In the interim, consultations with panel members are likely be through email or a tele/video conference. CDWG may consider face-to-face annual meeting with panel meetings to enrich discussions at personal levels. The panel members may be invited to be resource person/speaker in the CDWG-organized workshops and activities.
