## 2. SERD Health Program Opportunities

- Strategic directions of the proposed ADB Operation Plan for Health include:
  - Health Infrastructure and Health Human Resources
  - Health Governance and Regional Public Goods (including communicable diseases)
  - Health Financing, including equity, allocative efficiency and technical efficiency

# Issues for consideration

- Investment in infrastructure and equipment will be part of ADB engagement.
- Most of the opportunities will be in the provision of technical assistance including project preparation and specific issues (e.g. capacity building).
- Some health projects might use Results-Based Lending modality in the future, meaning fewer “hands-on” ADB intervention in the procurement and recruitment of firms.
