Aarogya Setu is a Covid-19 tracking mobile application developed by the National Informatics Centre (NIC)

The app was launched on April 1, 2020 and available in both Android and iOS mobile operating systems.

The app is currently used by 11.3 crores Indians and has a rating of 4.6/5 in play store based on almost 1 lac of reviews in play store.

The app is currently available in 12 languages - English, Hindi, Telugu, Kannada, Malayalam, Tamil, Punjabi, Bengali, Oriya, Gujarati, Marathi and Assamese.

Use of Aarogya Setu app has been made mandatory for all employees, both private and public from 2nd May 2020 and it will be the sponsibility of the head of the respective organizations to ensure 100% coverage of this app among the employees as per government norms

The app currently has become the most downloaded healthcare application worldwide and featuring amongst the world's top 10 downloaded apps.

Key Features of the App



The app uses Bluetooth and GPS tracking to provide information and requires every person to keep respective Bluetooth and GPS Location sharing turned on at all times

Chatbot facility to make initial assessment. If one phone user tests COVID-19 positive, all his details are crossreferenced with those that he came into close proximity with, pinpointed by digital ID and GPS information.

Digital e-pass available for supply chain, logistic and healthcare workers


User can get the COVID—19 stats displayed on Home Screen by changing the radius. The radius parameters can be : 500 meters, 1km, 2km. 5km and 10km.
