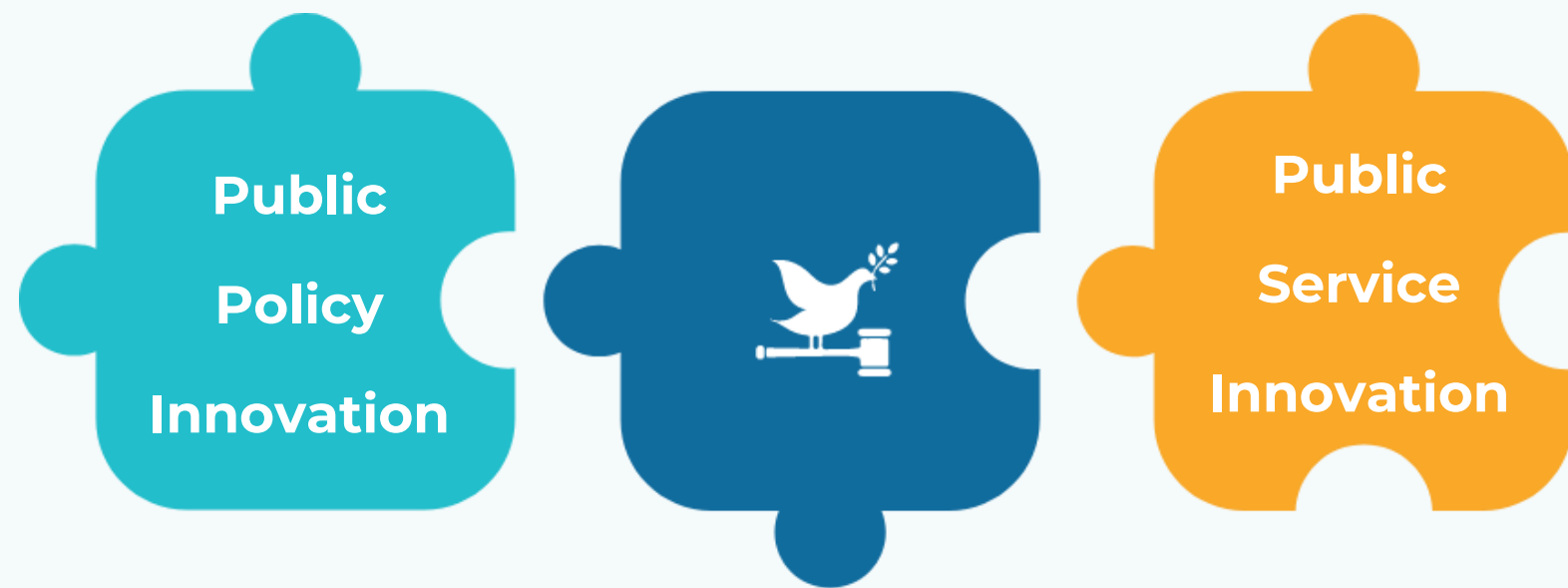

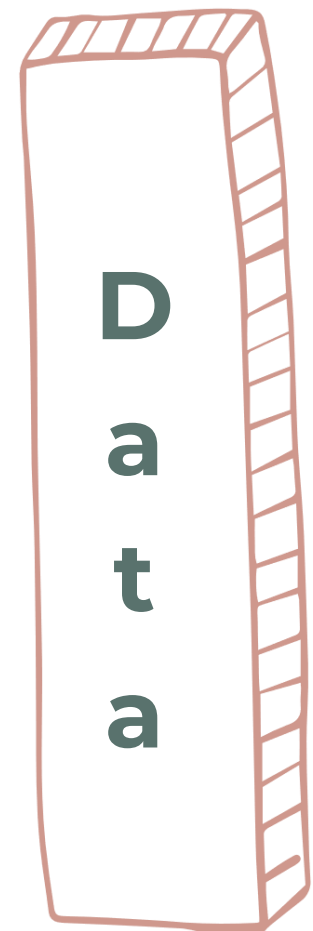

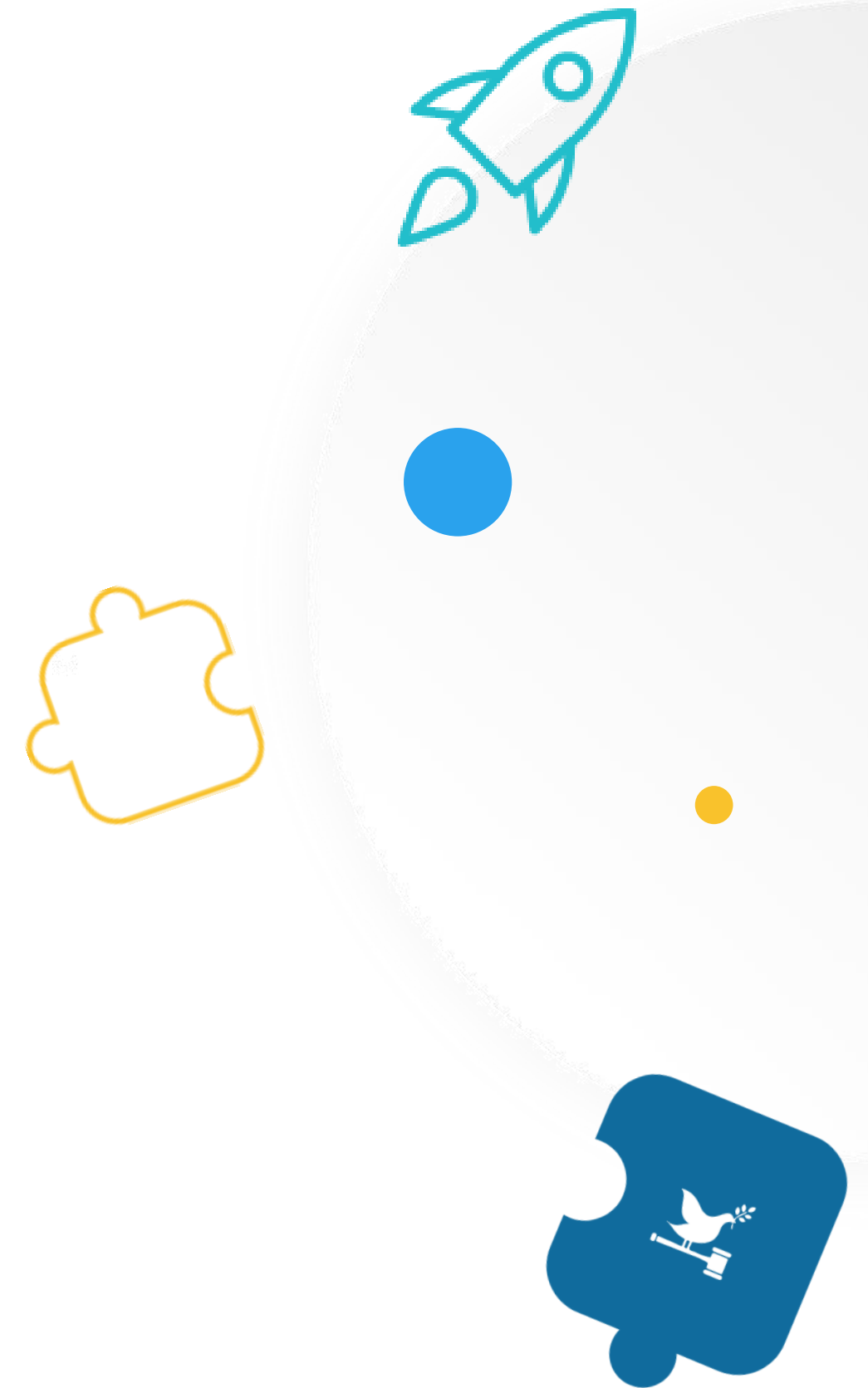

- Implemented together with the UNDP's "Rule of Law and SDG 16 in Armenia's Reform Agenda" project.
- User-friendly, AI powered, open-access interactive online data repository for real-time SDG progress monitoring in Armenia.
- Ownership of the process by the Deputy Prime Minister's Office.
- Over 10 public institutions in the project **Task Force**, partnership with **Oslo Governance Center** and **Global Data Barometer**.
- Data collection through conventional and non-conventional methods.

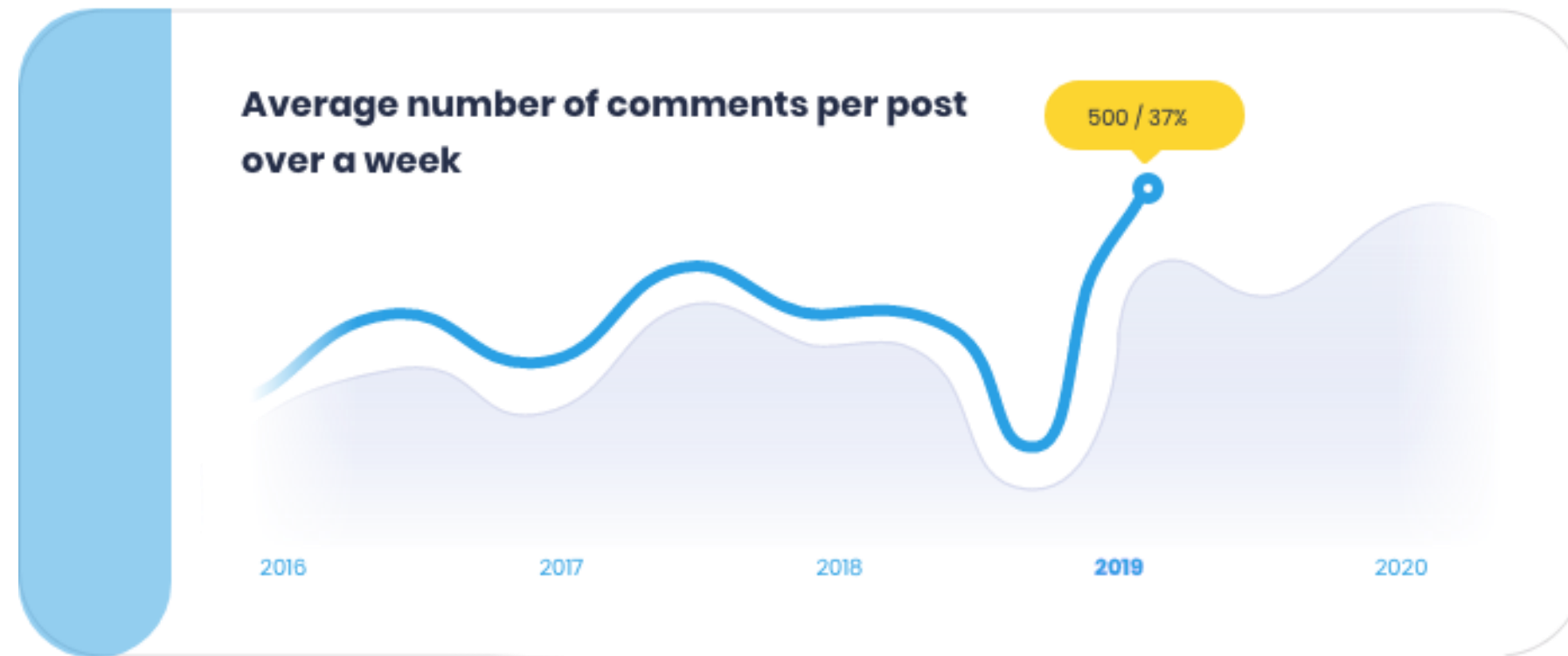

Innovative data collection

SDG 16.7.2

Proportion of population who believe decision-making is inclusive and responsive, by sex, age, disability and population group



- Daily, weekly, monthly and annual seasonality and trends for posts, comments, reactions and specific topics;
- Time-series analysis of the number of posts, comments, reactions, shares, etc.;
- Time-series analysis of the number of legal acts, likes, dislikes, views, comments, amendments/incorporations.



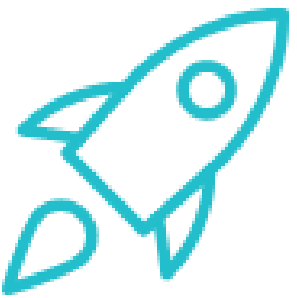

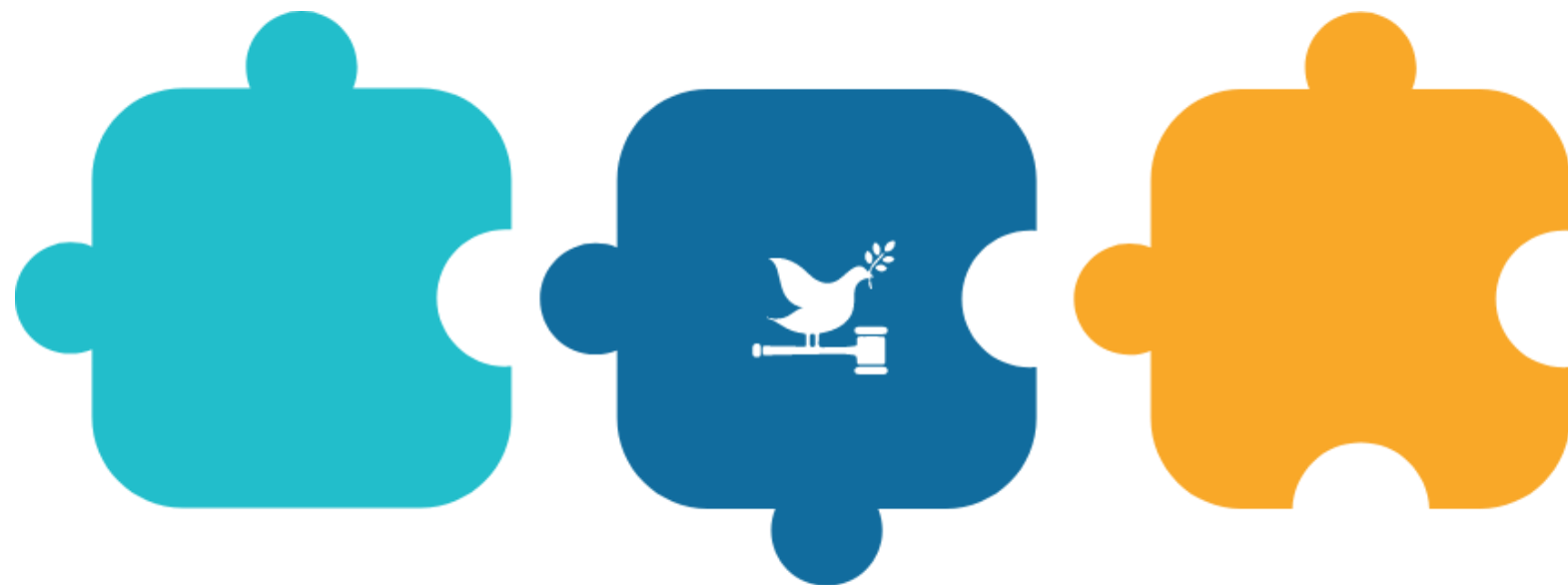

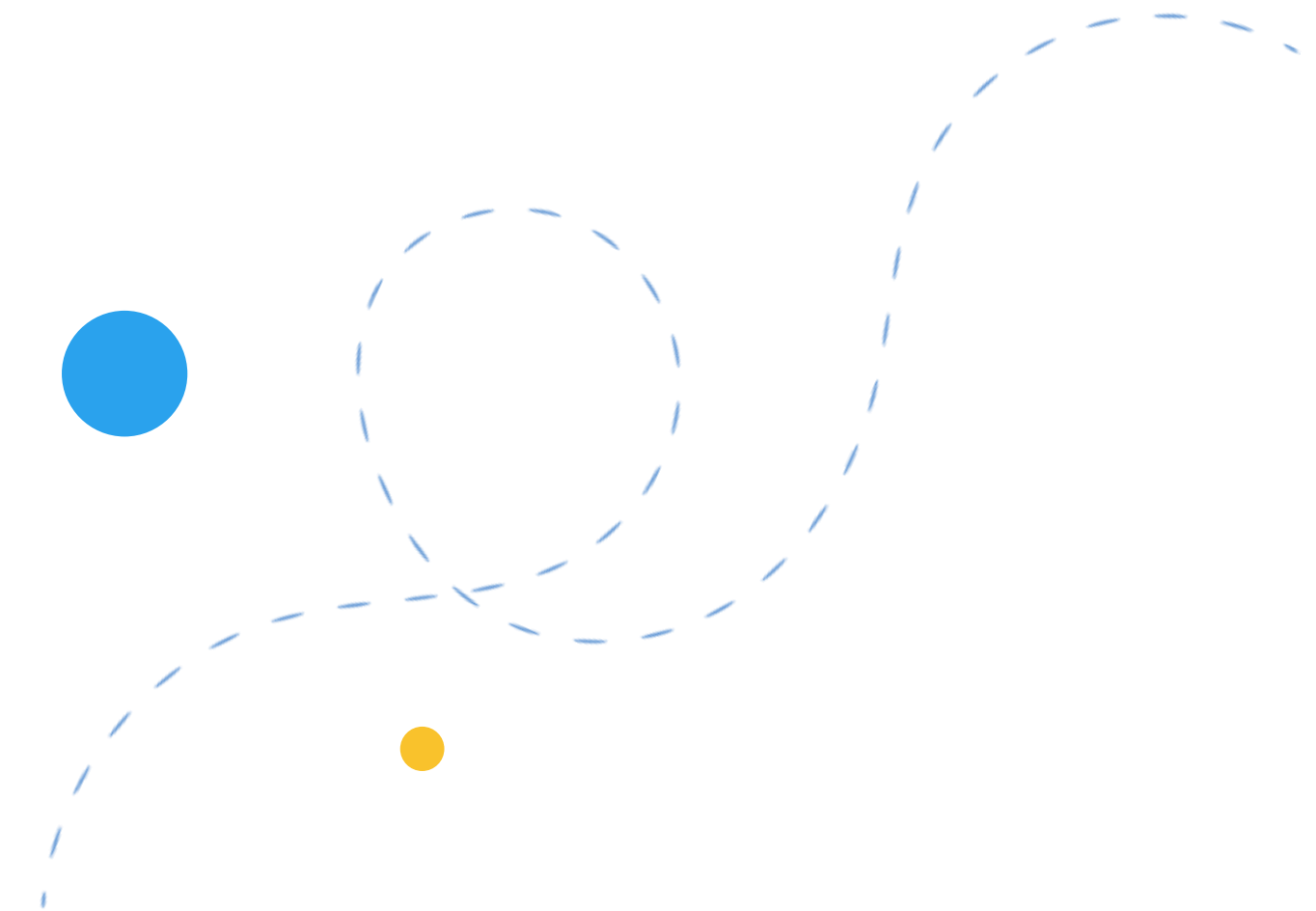
Research and recommendations for public policy innovation

UNDP Armenia's non-traditional financing mechanisms for development

Innovative financing mechanisms and impact investment ecosystem development to attract private capital and action for the SDGs:

- Private-sector funds as seed capital for public policy innovation and public service reform programs (MTS Armenia telecommunication company)
- Investments in technology-driven SDG-oriented ventures (Tech4SDGs Impact Fund)
- Market intelligence product to attract foreign investment (SDG Investment Map)
- Social impact bonds, green bonds, diaspora bonds, fintech incubator/ accelerator
