

# Why is sanction screening important?

#### **ADB's Procurement Policy**

#### VII. Integrity


 ADB requires application of the highest standard of ethics during any procurement process subject to this Policy and use of funds, resources, assets, and authority in accordance with ADB's Anticorruption Policy and Integrity Principles and Guidelines (both as amended from time to time) (Anticorruption Guidelines).

#### ADB's Procurement Regulations, paragraph 1.18 e)

(e) A firm or individual sanctioned or temporarily suspended by ADB in accordance with ADB's Anticorruption Guidelines shall be ineligible to participate in or to be awarded an ADB-financed or ADB-administered contract or to benefit from an ADB-financed or ADB-administered contract, financially or otherwise, during the period of time determined by ADB.

Financing agreement required EAs to comply with these eligibility requirements. They are reflected in all ADB's Standard Bidding Documents and Requests for Proposals and are applied to all stages of tendering process under ADB projects.

# **Executing agencies (EAs) are responsible** for sanction screening



### How should EAs undertake sanctions screening?

- Check bidders against the published UN Security Council Sanction List
- Request access to OAI's Sanction List and check against it
- Reflect the results of sanction screening in bid evaluation reports or recommendations for contract award (in case of direct contracting) submitted to ADB

### **Special Considerations**

- Under post-review (sampling), EA remains responsible for conducting sanctions screening at all stages of the procurement process before signing a contract
- For non-sovereign operations, ADB requires borrowers to demonstrate that procurement was transparent and preferably conducted through competitive bidding. EAs must confirm that the contracted entities are not on OAI sanction list.
- When ADB is participating in financing PPP transactions, entities on the ADB sanction list are not eligible to become project sponsors.

### **Risks to EAs**

- If an EA fails to conduct the required sanction screening at various stages before a contract is awarded, and a first-ranked bidder is found to be debarred or temporarily suspended by ADB, ADB will not issue its no objection to contract award recommendation.
- If an EA awarded and signed a contract with debarred or temporarily suspended (i.e. ineligible) entity, ADB will take appropriate action, including declaring misprocurement/noncompliance and canceling its financing.

This represents reputational and contractual risk to EAs since contractors will demand payments. While contractors can terminate contracts if funding is not available but are still entitled to claim financing charges under "Delayed Payment" provisions.





## **Managing the Access**

IAs and EAs should

- Designate the appropriate person(s) from the organization/agency requiring access on a 'need-to-know' basis
- Not share user accounts or passwords each user must apply for a unique user ID.
- Submit accurate, detailed information that allows the user ID to be identifiable to a single user
- Inform ADB (integrity@adb.org) or ADB project officer if the user profile details have changed since the initial request or require deactivation (access no longer required or user no longer connected with the EA)


