

•


- Unsustainable human pressure on ecosystems
- The COVID-19 pandemic highlighted the cost of inaction
 - One Health is an approach to human, animal, plant and ecological health that is premised on their interconnectedness

One Health addresses DMC's big health challenges

The big-picture issues that One Health is aligned with are highly relevant to the region: zoonotic diseases, antimicrobial resistance, food security, pollution, and climate change.







One Health is key to Post-COVID-19 green economic recovery

Can yield multiple benefits through, e.g. improved agricultural practices, effective spatial planning, and greening of supply chains.

One Health is key to regional and global health security


Transboundary cooperation and cross-sectoral support on issues such as transport, urban planning, labor, environment, agriculture, and social policy benefit from a One Health approach.

Can help overcome antagonisms between different SGDs





One Health in ADB's DMCs

GMS Health Cooperation Strategy prioritizes One Health through cross-sectoral and cross-thematic approaches

GMS Strategic Framework 2030's adoption of One Health response that takes a unified view of animal and human diseases and their interactions

GMS One Health activities: cross-sectoral disease outbreak response; information sharing; joint capacity development; One Health University Networks
