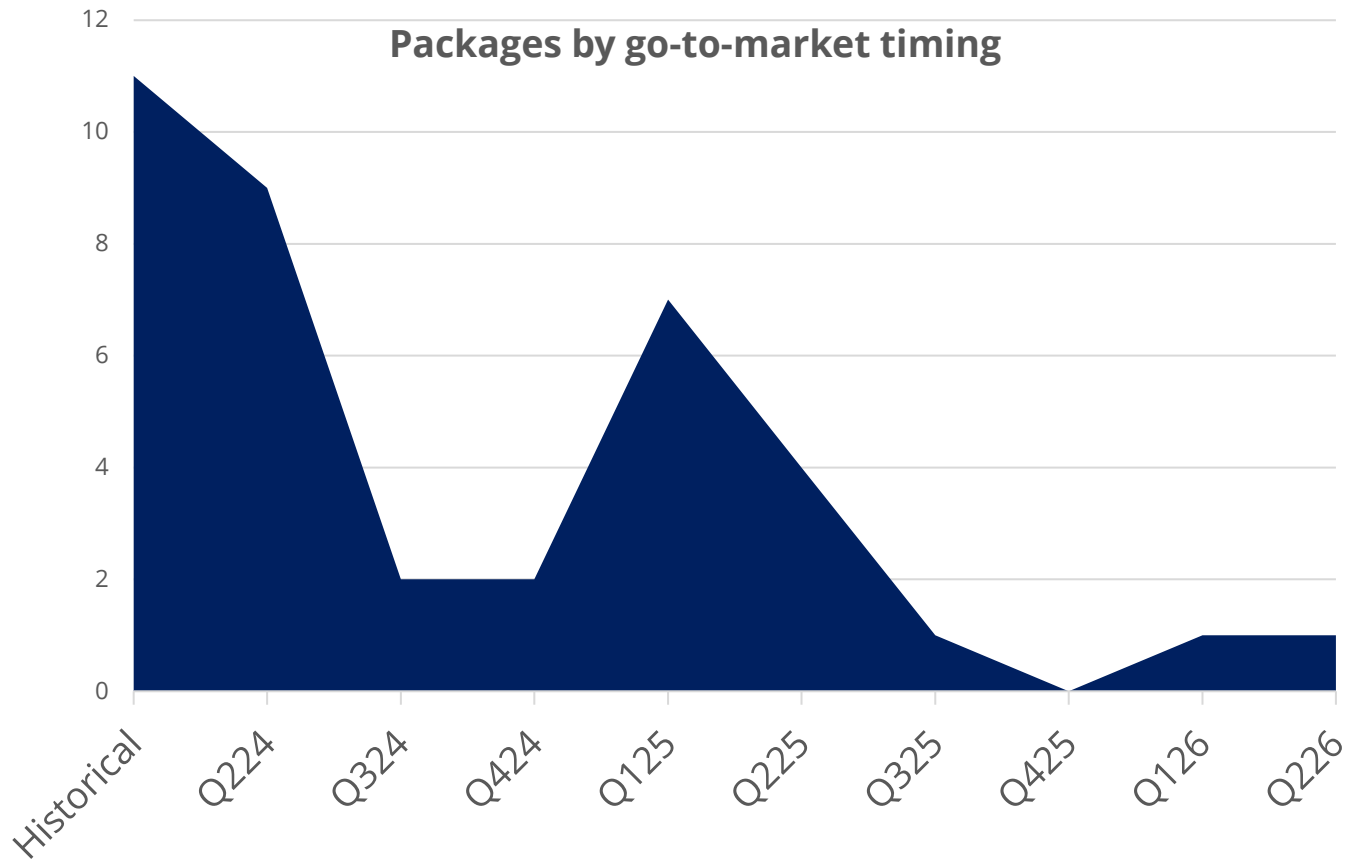
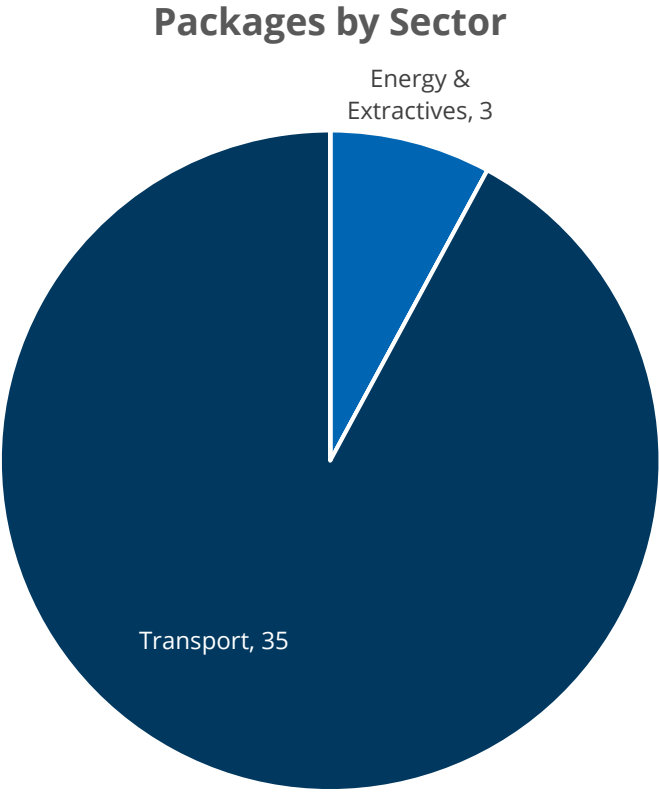

Local Participation Opportunities Highlights

- For the central government, 80% of our tenders go to local businesses
- Infrastructure and civil works for our major projects are expected to go to local businesses either directly or through sub-contracts
- Looking at community led procurement

Update on Country Procurement System

- Procurement Regulations 2024 approved by Fiji Cabinet (Replaces Procurement Regulation 2010)
- New Regulations Focus on value for money, sustainability and risk management.
- **NEW:** All organizations , entities that receive government fund must be comply with procurement principal' stated in Procurement Regulations 2024
- Different procurement methods for varying project sizes (13 Procurement methods)

Procurement Principles

- A. Maximising value for money;
- B. Promoting open, fair, inclusive, and equitable competition amongst suppliers and contractors;
- C. Achieving integrity, accountability and transparency to maintain public confidence in public procurement processes;
- D. Applying appropriate risk mitigation in compliance with applicable risk management frameworks; and
- E. Ensuring sustainable procurement of fit for purpose goods, works and services.
