Elements of Livelihood Restoration Planning

When is a standalone LRP needed?

Standalone Livelihood Restoration Plans

- Tend to be used in more complex projects with large-scale land acquisition >> diverse activities
- may require additional activities such as market assessments,
- Also seen in
 - targeted programs for APs in resettlement sites;
 - targeted programs based on recipients:
 - LRPs can also be used in any-scale of project if there are other rationales

How do Livelihood Restoration Plans and Resettlement Plans complement each other?

Resettlement Plan

- IOL/DMS, SES, consultations
- Compensation and additional assistance based on socioeconomic conditions of households and magnitude of impact
- Implementation completed prior to land take and prior to civil works

Livelihood Restoration Plans

- Assessment of livelihood systems, needs assessment, other specialist studies i.e. market analysis, consultations
- Specific activities specifically targeted at restoring, expanding, improving the livelihood systems of eligible affected persons given their remaining resource base after resettlement, additional assistance, and skills and interest
- Implementation can continue during civil works

Examining Livelihood Systems

- Affected by land acquisition and land use restriction
- monetary income and non-monetized means of sustenance from various sources and resources.
- The restoration of livelihood systems accordingly involves the replacement of all lost resources and sources of income, including physical assets with assigned monetary values and non-market means of livelihood
- Challenges in valuation
