Marine litter is transboundary


Sources and sinks may be in different countries

## Strategic Directions 2023-2027

Marine pollution prevention, reduction and control (incl. plastic from land &sea)

Regional Action Plan on Marine Litter (RAP MALI) Adopted by IGM 24 (2019), aligns with UNEA & 2030 Agenda Working Group on Marine Litter & Expert Group on Monitoring



ACTION 1: prevent and reduce marine litter from land-based sources

ACTION 2: prevent and reduce marine litter from sea-based sources

ACTION 3: strengthen monitoring and assessment

ACTION 4: create enabling conditions for action, e.g. knowledge sharing, regional coordination, research, awareness raising

## CHALLENGES IN THE EAS REGION

- Fragmentation? Different legal frameworks, data methods, reporting formats across COBSEA countries > hard to compare & coordinate
- Interoperability gaps? Siloed national systems limit regional data integration
- Capacity gaps? Many agencies need stronger tools, training, and resources
- Trust & transparency? Data sharing limited by concerns about ownership, misuse, reputational risk
  - COBSEA's Regional Guidance on Harmonized National Marine Litter Monitoring Programmes adopted by IGM 25 (2021)
  - Towards a Regional Assessment of Marine Litter in the East Asian Seas (Cambodia, Malaysia, the Philippines, Thailand and Viet Nam) endorsed by IGM 26 (2024), opportunity to expand to remaining ASEAN countries to harmonize monitoring approaches
  - Regional training of trainers; national trainings in Cambodia, Malaysia, Philippines, Thailand, Viet Nam






# BUILDING DATA SYSTEMS THROUGH REGIONAL–GLOBAL INTEGRATION

Strengthening data governance requires robust systems that ensure:

- High-quality data —accurate, complete, timely, and verifiable
- Interoperability —open platforms that support real-time data sharing
- Capacity building —empowering local actors through practical training and tools
- The Global Plastics Hub (UNEP HQ): an open, multi-stakeholder platform aggregating global data and resources on marine litter & plastic pollution
- UNEP COBSEA's Regional Node connects with the Global Plastics Hub to align regional & global efforts, supporting RAP MALI implementation





## WAY FORWARD & OPPORTUNITIES

- Strengthen regional data frameworks, aligned with global efforts
- Explore piloting shared dashboards and metadata standards
- Support & amplify national innovations among COBSEA countries
- Explore synergies with partners (e.g., ADB's digital roadmap) to promote circularity, traceability, and capacity-building
- Build interoperable, inclusive, transparent data ecosystems
- Shift from fragmented reporting to coordinated action
- Enhance traceability, accountability, policy enforcement

Through leveraging existing mechanism (e.g., RAP MALI, COBSEA Working Group on Marine Litter, WGML)
