Improved support for borrower-administered procurement (delegated TAs)



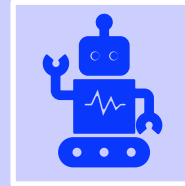

Phase 3: ADB-administered procurement of individual consultants & Borrower-administered advertisement of consulting services selection

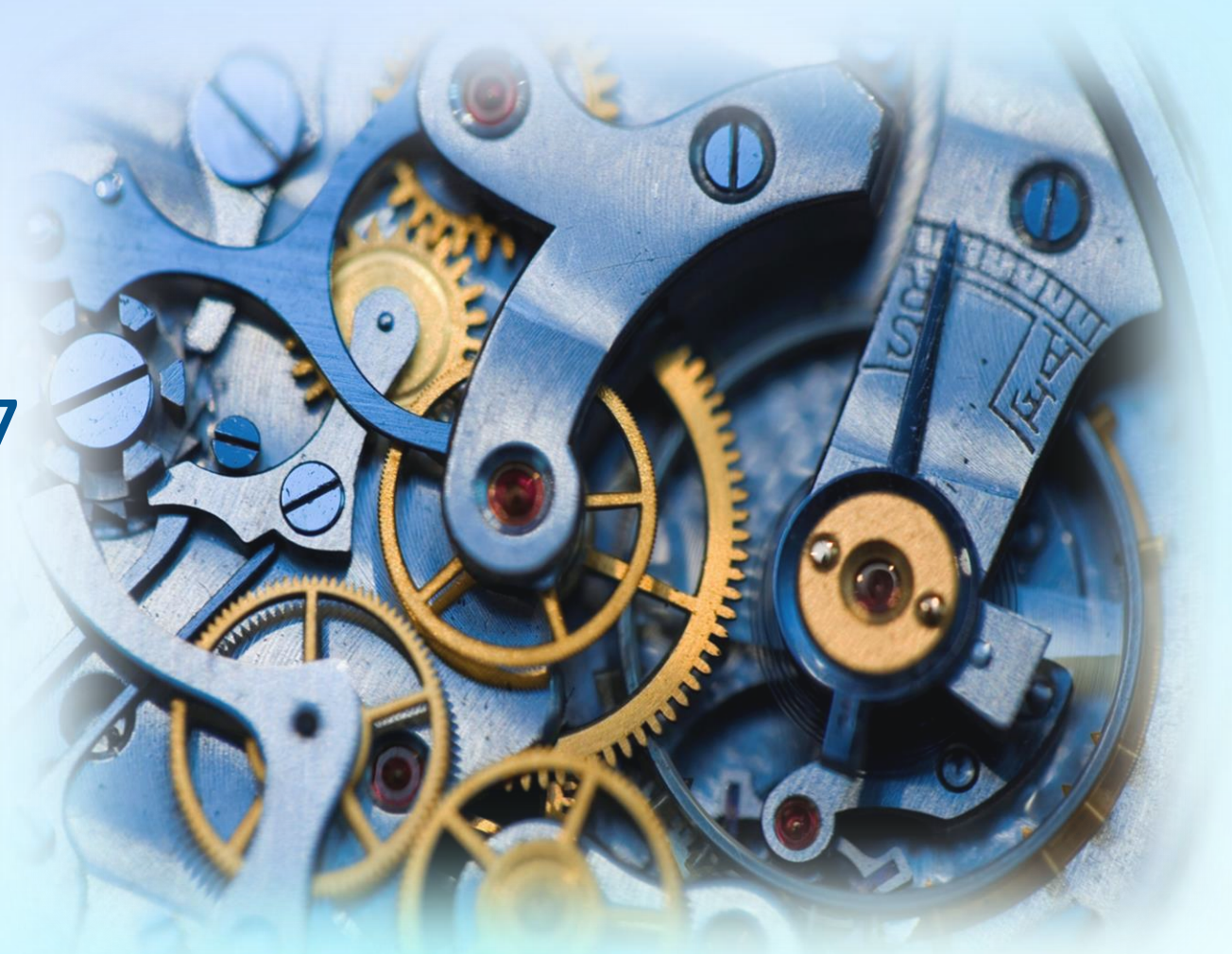
