



# HOW TO RESPOND TO AN EXPRESSION OF INTEREST-

SUBMITTING A RESPONSE

#### Provide a 4-page response that:

- demonstrates your capability against the relevant evaluation criteria
- demonstrates your subject matter expertise
- provides confidence that a value for money solution could be delivered
- tailors your capabilities specific to the evaluation criteria and project

# REQUEST FOR TENDER -PROPOSAL TO DELIVER THE SERVICES

Criterion 3: Demonstrate your capability to collaborate with multiple stakeholders and partners, including DFAT, to implement the Platform.

Guidance Note: Tenderers to demonstrate their approach to "ways of working", and how they will build a positive organisational culture, build successful teams, and ensure productive working relationships with DFAT and partners.

Criterion 4: Demonstrate your capability to maximise opportunities and engagement that deliver on the Australian development priorities (as outlined in the statement of requirements).

Guidance Note: Tenderers to demonstrate how they would support policy priorities including gender, disability, climate, and locally led development. Tenderers to focus on clearly proposed deliverables and targets and how they will meet those deliverables and targets. Final deliverables and targets will be negotiated with DFAT and will form part of the Contract.

Criterion 5: Demonstrate your resourcing capability to successfully implement the Platform, with a focus on responsiveness and adaptability, and explaining how this approach provides value for money.

Guidance Note: Tenderers to demonstrate how they will manage resources to deliver the Platform. Tenderers to outline operational, technical and other resources they will provide to support the recruitment, mobilisation, management and leadership of the Platform and for the Platform to service sector programs.

Tenderers must complete Tables 1, 2, and 3 below. In Table 1 demonstrate all proposed positions and inputs (days or months) required to deliver the Platform Services including any unallocated positions, contractor representative and/or head office positions with substantial inputs. Names and CVs are not required at this stage.

Tenderers to note that all management fees; operations, administration and support personnel (HR, finance etc); and development services personnel (ie GEDSI, MEL etc) required to deliver the \$135m of the initial term contract are to be charged to Services Order 1 providing the services of the Platform. Services orders for sector programs may not be charged for management fees or support personnel – all must be in Services Order 1. Development services personnel (i.e. GEDSI, MEL etc) should be centralised under Services Order 1, however some development services personnel may be included in sector programs services orders for the larger sector programs (e.g. health and education programs). Tenderers should nominate their approach to how they will engage development services personnel to work across the \$135 million project and deliver value for money, and to what Services Order they will be charged.

Tenderers should consider all cost savings or other benefits their tender can offer in the provision of the Services. Describe an enhanced value for money basis of payment, detailing milestones/deliverables and reporting frameworks and incorporating payments linked to performance and program achievements.

Tenderers should nominate an approach to management fees that is flexible to adjust to a decreased or increased budget over the initial term of the contract.

Please include detailed narrative and assumptions to assist the evaluation of your resourcing proposal. Final resourcing and costing will be negotiated with DFAT.

# PROPOSAL TO DELIVER THE SERVICES

### Some helpful tips

#### **Gather information:**

- read and consult
- use the collaboration
- ask questions through the procurement mailbox.
- keep up-to-date through AusTender.

#### For your response:

- consider value for money throughout the bid not just 'lowest cost'.
- read the guidance notes
- respond to the criteria (answer the question) with evidence
- reflect on lessons learnt
- explain how you will measure success
- consider resourcing
