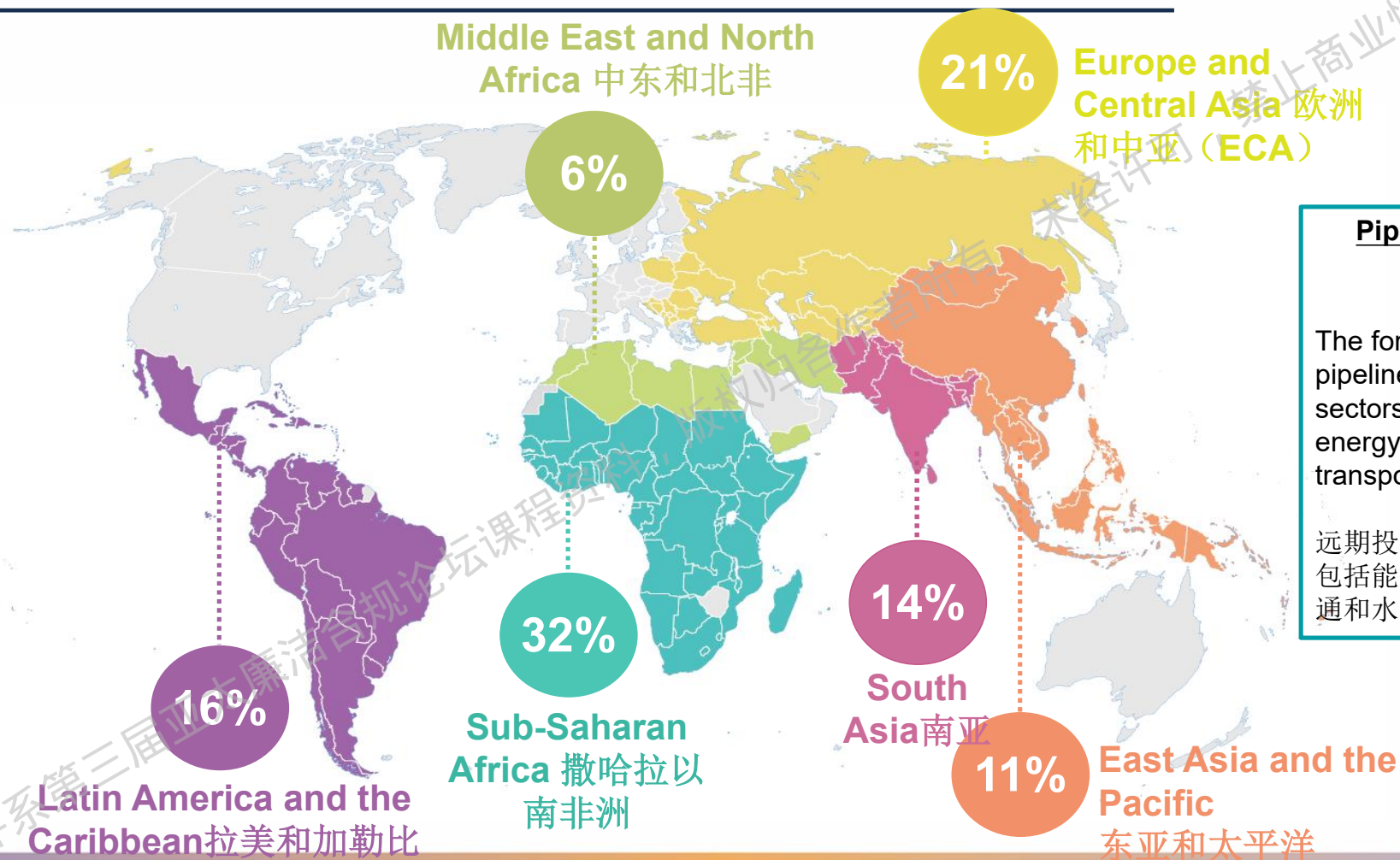

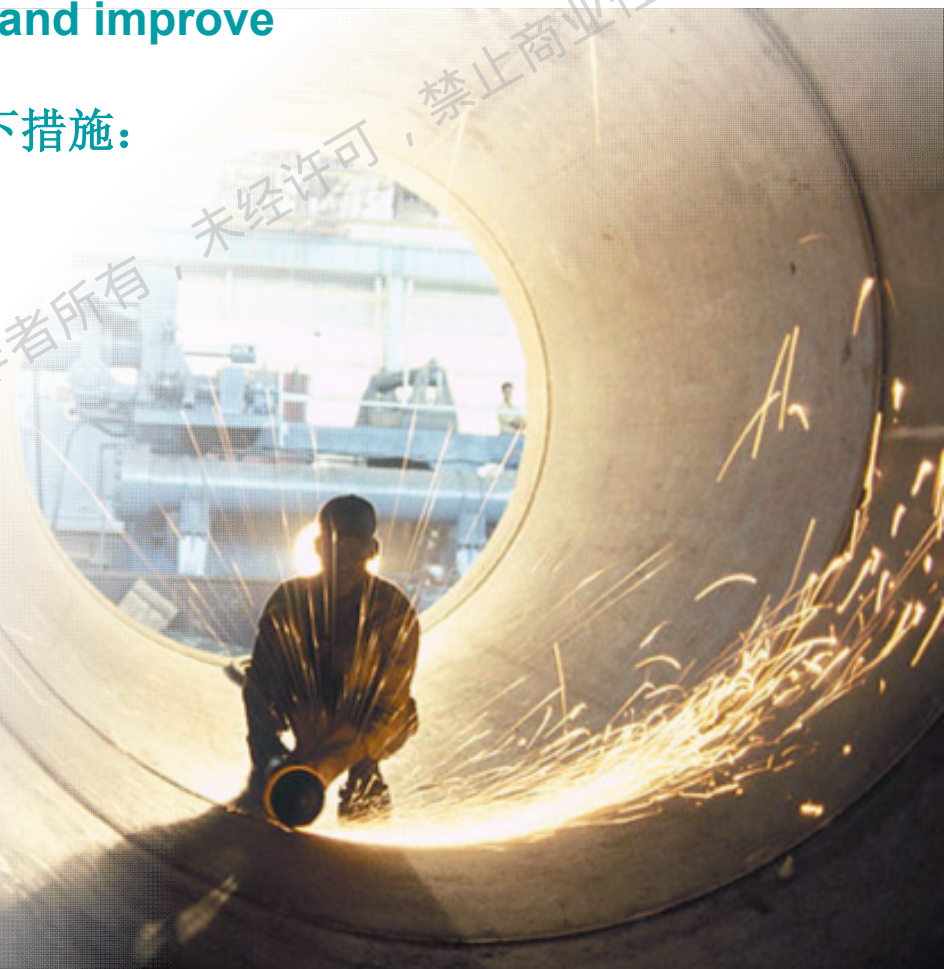

# RATED CRITERIA 打分法

Since 2016, the Bank's Procurement Framework has permitted the use of Rated Criteria to evaluate Bids and Proposals.

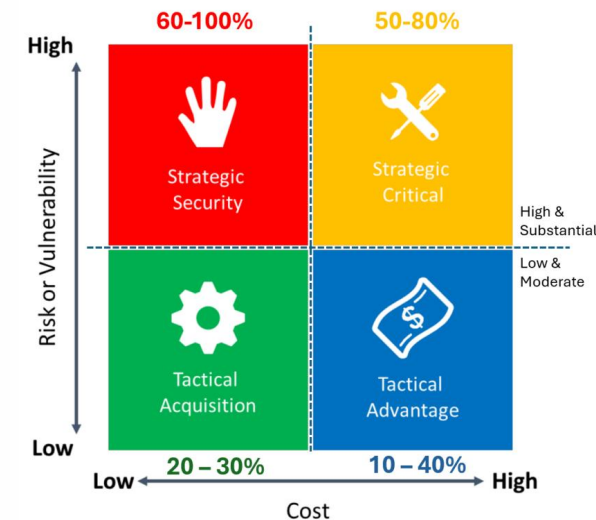
## What are Rated Criteria? 什么是打分法?

Rated criteria are evaluation criteria used to assess non-price attributes of bids or proposals. They are designed to ensure that the evaluation is comprehensive, transparent, and aligned with the objectives of the procurement. 打分法用于评审投标书或建议书的非价格属性的评审标准。这些评估旨在确保评估全面、透明并与采购目标保持一致。

*\*Note: Rated criteria is not mandatory for pharmaceuticals, vaccines, future commodities and direct selection.*

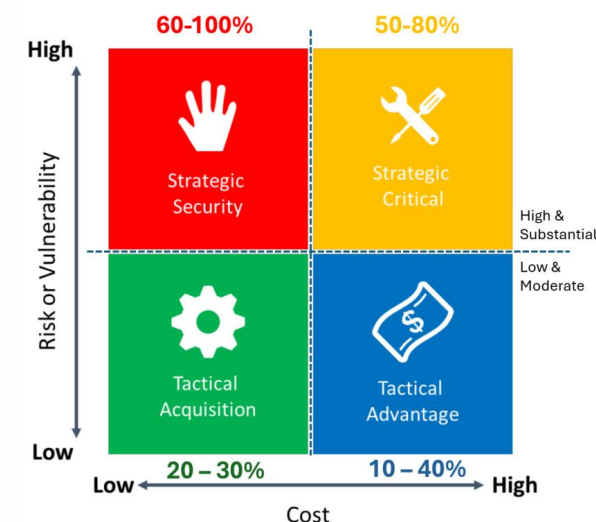

International procurements must use specific minimum quality weightings based on their value and risk, meaning most international procurements will require a **minimum 50% weighting for quality**.

### Why are local and low carbon supply chains important?

为什么本地和低碳供应链很重要？

- Majority of emissions (>75%) for an average business are generated by its supply chains. 一般企业的大多数排放（>75%）是由其供应链产生的。
- Bank-financed procurement is a significant consumer of goods, materials, and services for many sectors including carbon intensive sectors. 世行资助的采购对包括碳密集型行业在内的许多部门来说都是商品、材料和服务的重要消费者。
- Production of cement, steel, aluminum alone contributes to 15% of global emissions. 仅水泥、钢铁、铝生产就占到全球排放量的15%。

- Also encourages high-capacity suppliers to participate in Bank-financed procurement. 鼓励高能力供应商参与世行资助的采购。

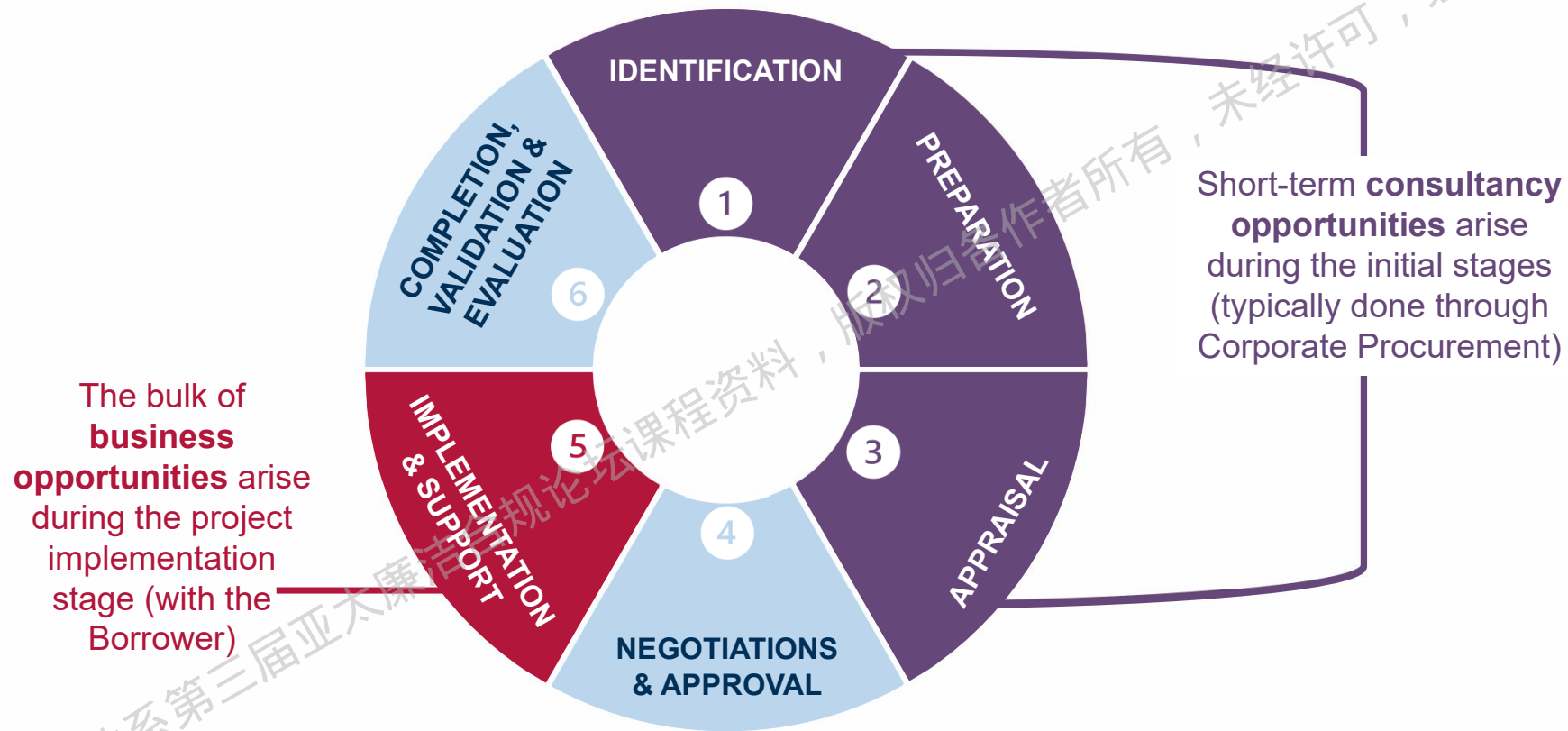

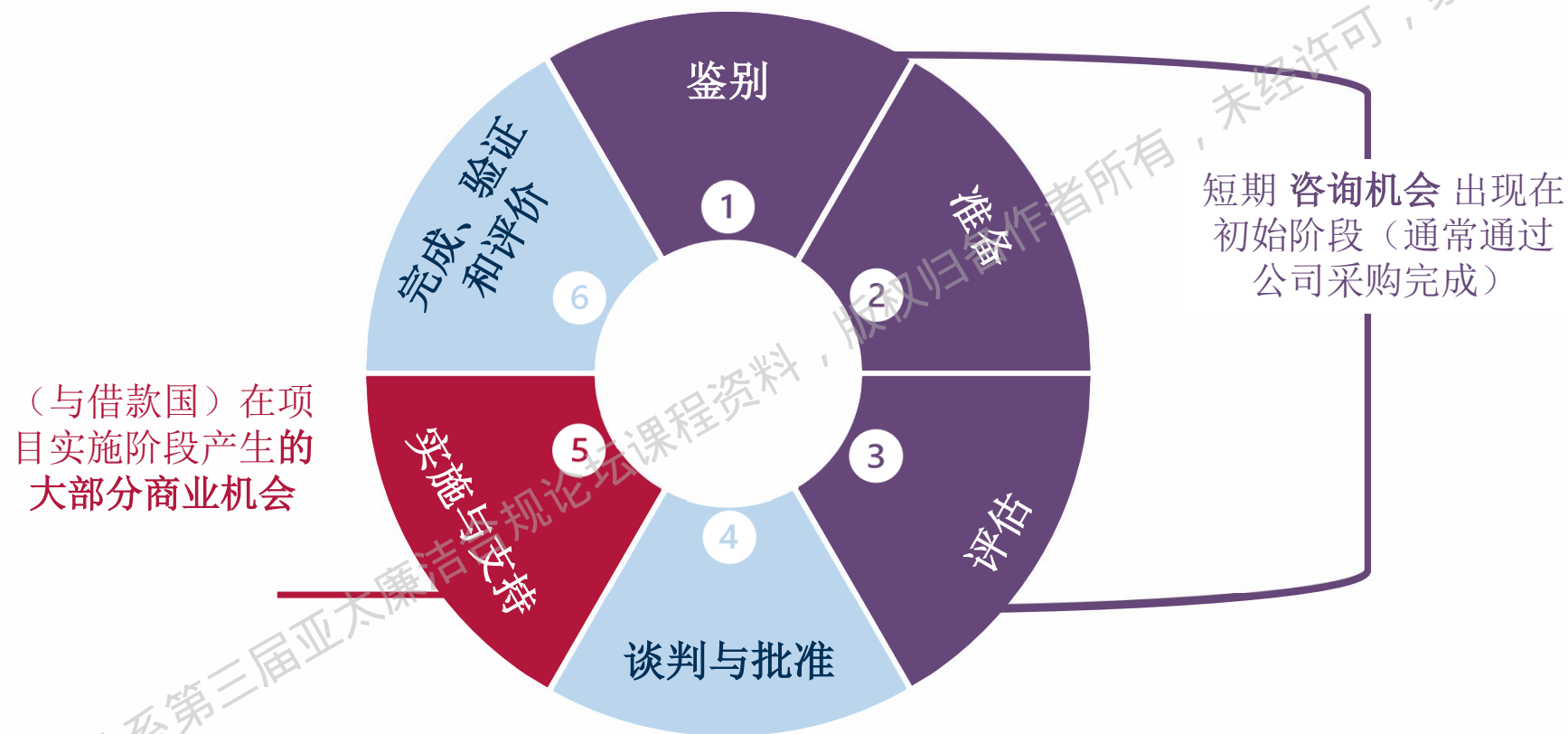

### Tips for preparing bids and proposals 准备投标书和建议书的提示



- ❑ Get involved with early-market engagement and pre-proposal briefing 参与早期市场参与和建议前说明
- ❑ Fully address all requirements 完全满足所有要求
- ❑ Emphasize your methodology for delivery – innovate if you can 强调您的交付方法—如果可以，就创新
- ❑ Propose a strong project manager and experienced experts 推荐强有力的项目经理和经验丰富的专家
- ❑ Cite relevant technical and regional experience relevant to the project – the more significant and similar the better 引用与项目相关的技术和区域经验—越重要和相似越好
- ❑ Identify and involve in-country “local partners” where possible, consider joint ventures 识别国内的“本地合作伙伴”并使其参与进来，并尽可能考虑建立联合体

- ❑ Demonstrate understanding of project Environmental & Social risks and how they could be mitigated 展示对项目环境和社会风险以及如何缓解这些风险的理解
- ❑ Offer suggestions for reducing GHG emissions 为减少温室气体排放提供建议
- ❑ Don't deviate from standard bidding document forms and conditions 不偏离标准招标文件的格式和条件
- ❑ Carefully review qualification and evaluation criteria and use these to help write the content and detail of your proposal 仔细审查资格和评审标准，并用它们来帮助编写您的建议书的内容和细节
- ❑ Failure to meet pre-qualification conditions leads to rejection 不符合资格预审条件者将被拒绝

- ❑ Check your understanding - if in doubt about anything contained in the bidding documents seek clarification from the Borrower's implementing agency undertaking the procurement 检查你的理解程度 — 如对招标文件中的任何内容有疑问，请向负责采购的借款人的实施机构寻求澄清
- ❑ Use trade missions and Executive Director's team for other concerns and questions 就其他关切和问题向贸易代表团和执行董事团队咨询
- ❑ Understand local laws and taxes – be aware of local customs 了解当地法律和税收 — 了解当地习俗
- ❑ Don't change Key Personnel without consent 未经同意不得更换关键人员

- ❑ Submit a professional proposal that is:

  - ❑ Comprehensive (covers all information requested)全面（包括所要求的所有资料）
  - ❑ Includes all supporting documents 包括所有支持文件
  - ❑ Signed by an authorized individual 由被授权人签字
  - ❑ Submitted before the deadline 在截止日期前提交
  - ❑ If joint venture, ensure all JV provisions are met 如果是联合体，请确保满足所有联合体条款的要求
  - ❑ Properly mark all envelopes enclosing the proposals 正确标记所有附上建议书的信封
- ❑ Be fully prepared before going into negotiation 在谈判之前做好充分的准备
  - ❑ Cover all bases (e.g. operational, legal, financial, project-specific risks & opportunities) 涵盖所有基础（例如运营、法律、财务、特定项目的风险和机会）

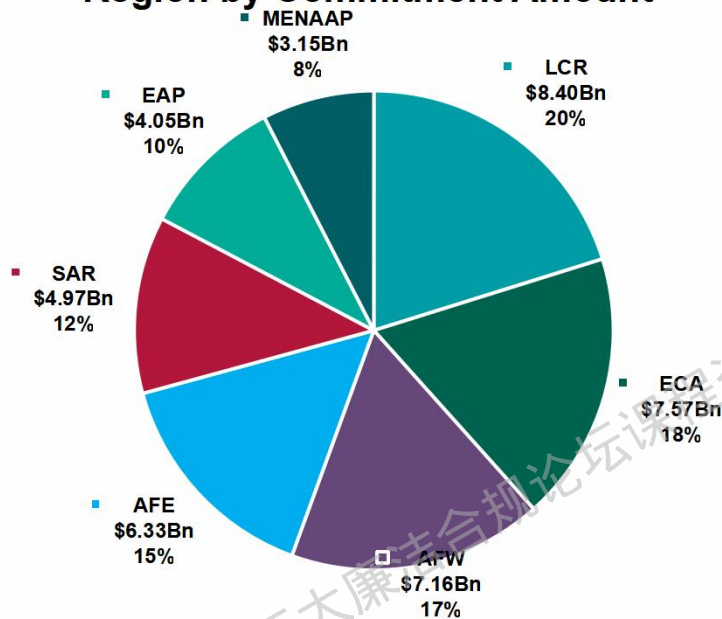

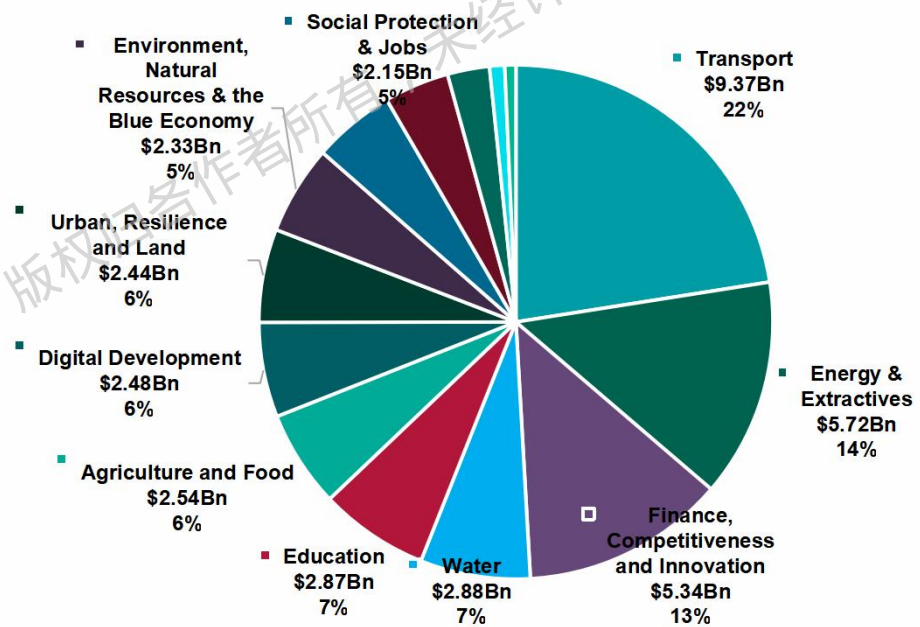

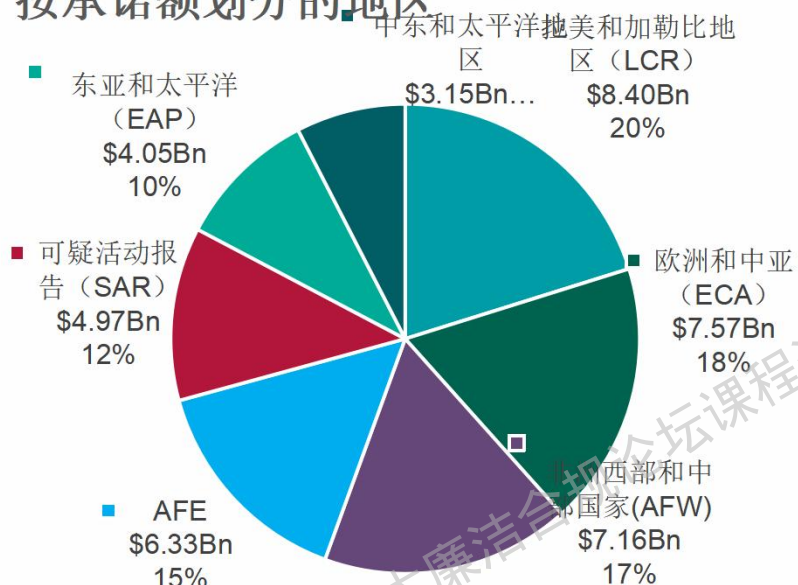

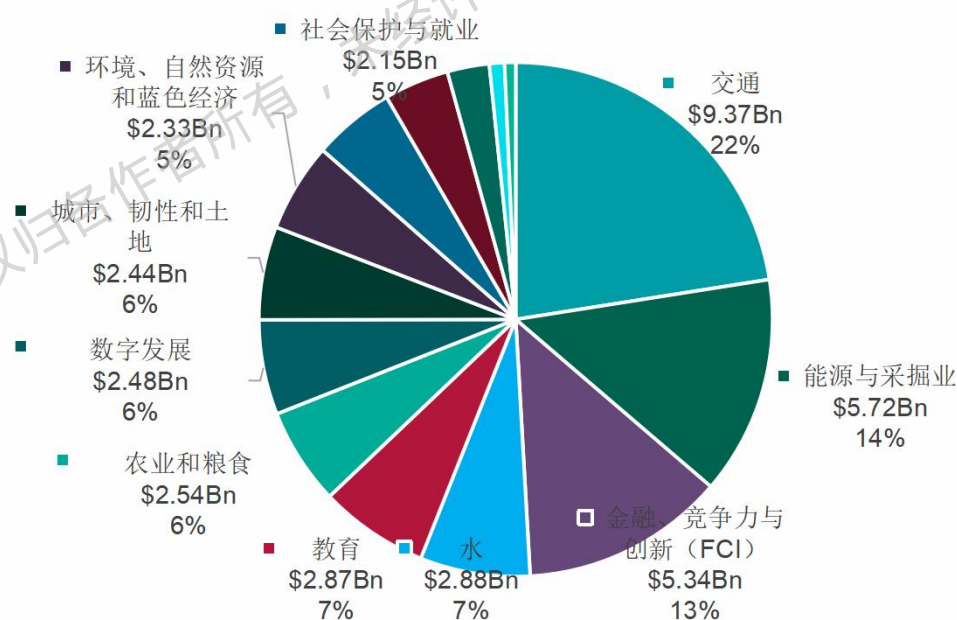

M300 will complement other efforts to power human capital and economic growth across the entire energy-sector value chain.

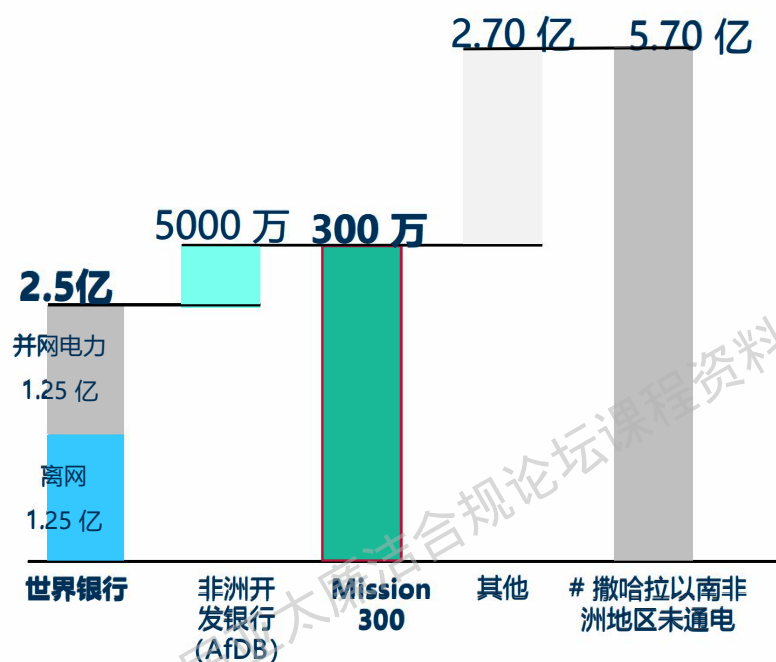

# Some of Mission 300 flagship programs

- MISSION 300

### Investment Projects

- **ASCENT**: Aims to connect 100 million people across 20 countries (Eastern and Southern Africa).
- **DARES (Nigeria)**: Will benefit over 17.5 million Nigerians, 20% of the unserved population.
- **RESPITE**: Will improve electricity access for millions across Chad, Liberia, Sierra Leone, Togo.
- **BEST**: Will improve access for millions in Côte d'Ivoire, Mali, Mauritanie, Niger, and Senegal.
- **ROGEAP**: Regional project to increase off grid connections for millions of people in 19 countries.
- **REMP**: Increase regional connectivity, integration and electrification (to be approved in January).

### Financing and De-risking Facilities

- **Africa Energy Future Platform**: A new equity vehicle to capitalize distributed renewable energy companies (joint effort between IFC, World Bank, MIGA, and partners).
- **MIGA and the Guarantee Platform**: MIGA's Guarantees team are working with IFC and the World Bank to integrate guarantee solutions into the equity vehicle design, streamlining access to de-risking solutions to attract private sector investment.

### Enabling Platforms

- **Electrifying Africa**: A US\$ 50 million technical assistance facility funded by ESMAP that helps countries develop reform roadmaps and provide just-in time technical assistance for WBG operations.
- **DARES**: Leverages collaboration across the World Bank, IFC, MIGA and development partners to significantly accelerate decentralized renewables (DRE) access through private-sector engagement.

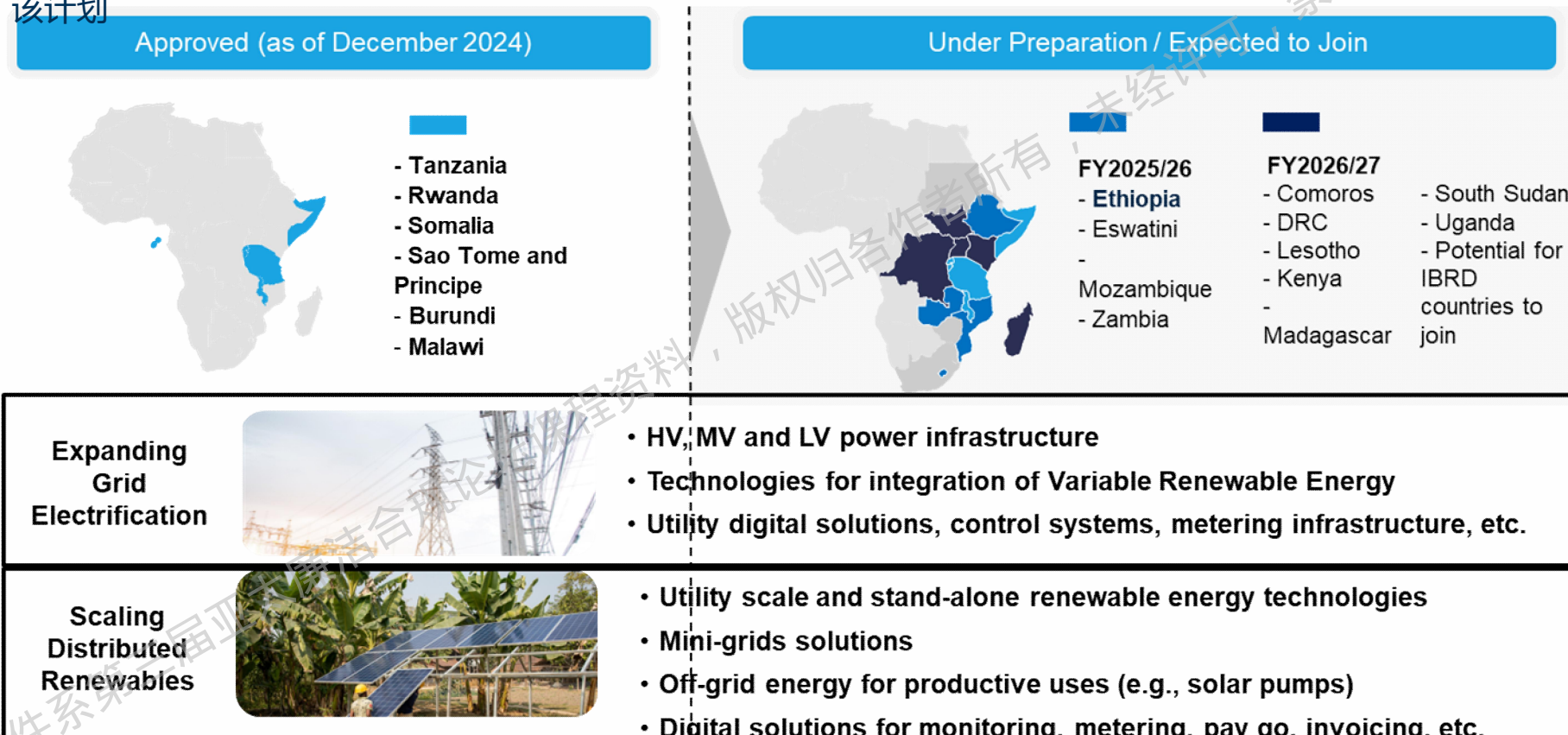

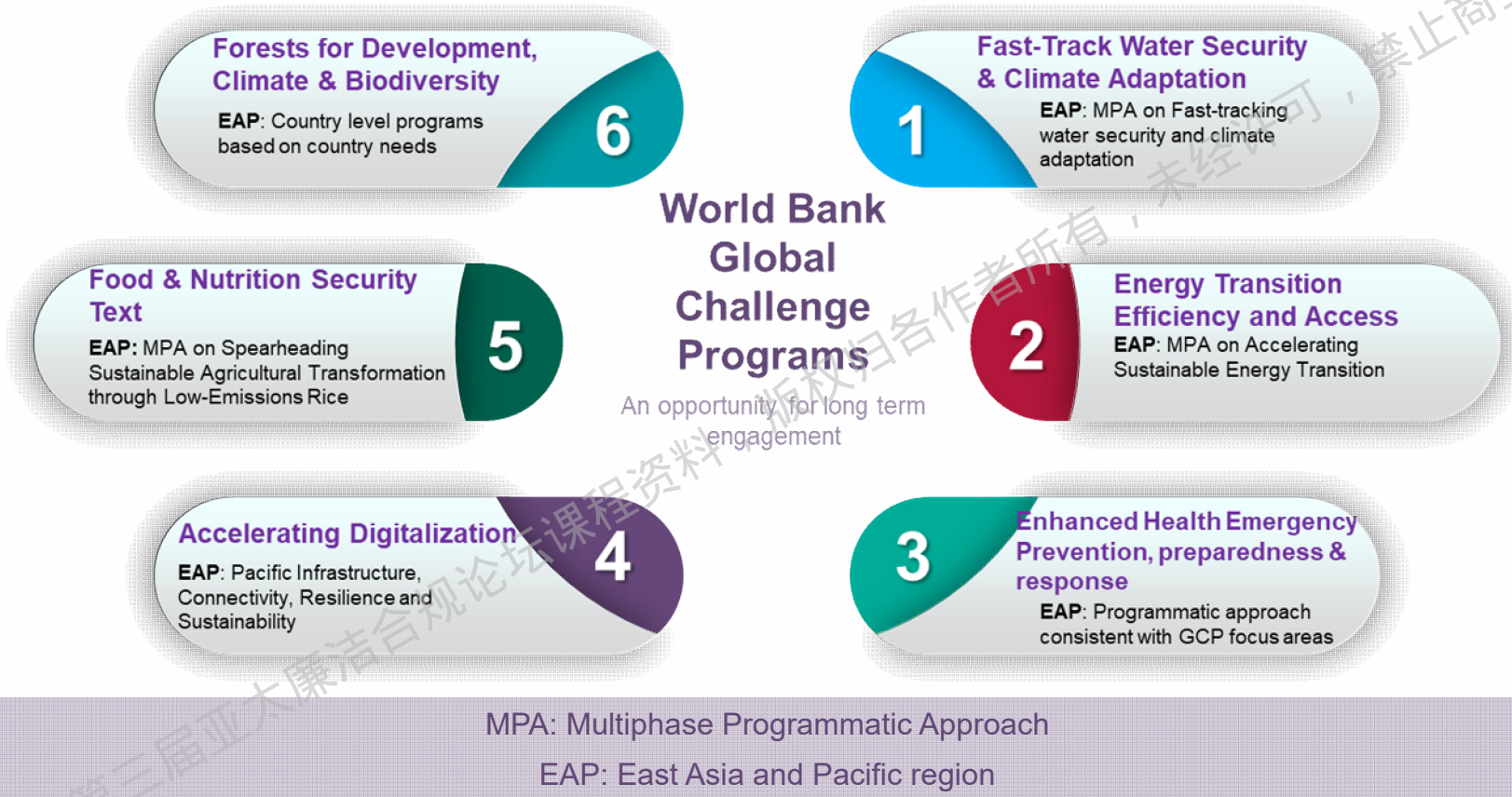
