- New Clark City (NCC) is an urban development project of BCDA, in which BCDA envisions to create an environmentally sustainable, smart and disaster-resilient greenfield city in Clark, Philippines.
- ❖ The Information and Communications Technology (ICT) project aims to introduce "open access model" for ICT infrastructure development in NCC to avoid duplicative investments by multiple internet service providers (ISPs) for provision of connectivity services. Under the open access model, ISPs will be able to lease fiber optic cables from a Joint Venture (JV) created between BCDA and private sector partner.



Scope of Work

- ❖ Transaction advisory services (TAS) is provided to prepare project's pre-feasibility study (define the scope of the project, develop a conceptual design for the network, preliminary costing, and a commercially viable business model) and to support the tendering of the project for selection of the JV partner.
- * TAS is expected to continue till commercial closing.



Project Background and Description

- The Project involves supporting the RBF to develop and implement a National Digital Identification (NDID) program along with an electronic Know Your Customer (eKYC) solution for banking customers as the first use case. The National ID would be a digital identity using a random unique number, biographical data (name, date of birth, etc.) and biometric information.
- The project is expected to result in lower cost of services for citizens, better targeted subsidies, more efficient remittance, and greater financial inclusion.




