

Background

- The Philippines continues to suffer from unequal access to high-quality health services, both geographically and financially, resulting in suboptimal health outcomes.
 - BARMM region has no level 3 hospital beds; only 4 X-Ray machines and 3 CAT scan machines
 - Majority of other regions have only 0.01 to 0.03 level 3 hospital beds per 1,000 population
- 2. The DOH Health Facilities Enhancement Program spent ₱144 billion on upgrading facilities from 2017 to 2023, but there are only 1,2 beds per 1,000 population and facilities are concentrated in urban areas.
- 3. Investments are thus required to enhance the capacity of health facilities and laboratories in non-metro areas.




Output 1: Enhance Capacity for Delivering Climate-Smart

Output 1

- Construction and equipping of specialized services in 12 DOH hospitals
- Provision of essential equipment for >30 BUCAS Centers,
- Construction and equipment of 4 oxygen plants and oxygen tanks and concentrators for 20 sites

Output 2

- Construction and equipping of 4 regional laboratories
- Equipment for routine and emergency blood services at 11 sites
- Upgrading and equipping of 4 FDA buildings

Output 3

- Strengthening of financial management, procurement, supply chain, and logistics information systems
- Strengthening hospital, lab, and health facility information systems
- Strengthening of project management within DOH

- The ACCESS UHC is a large procurement project, and half of the project amount (about \$250 million) will be spent on equipment, and additional considerable investments are devoted to climate-resilient health infrastructure
