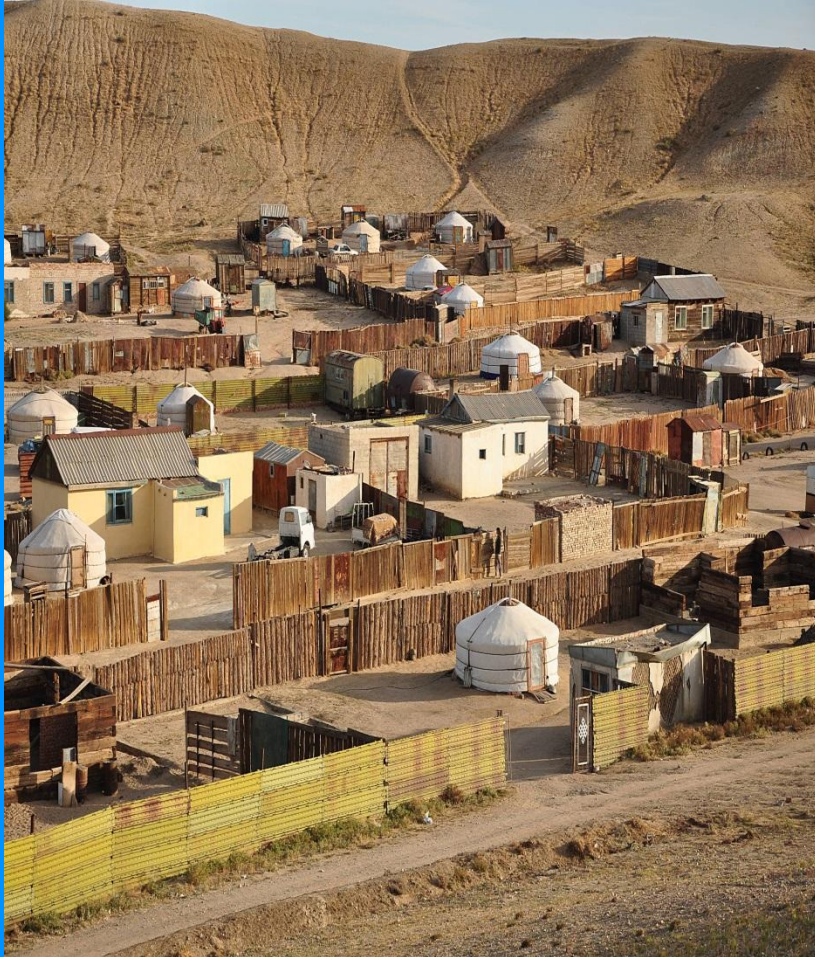

MONGOLIA: **BRIEF HISTORY OF** ADB OPERATIONS

- 1991 – Mongolia joined ADB
- 2001 – ADB Mongolia Resident Mission was opened
- Asian Development Fund grants and loans of over \$1.3 billion from 1991 to 2014
- 2011 – Mongolia gained access to ADB's Ordinary Capital Resources

URBAN DEVELOPMENT: PAST AND ONGOING ASSISTANCE

- As of 31 December 2014, ADB provided urban sector loans and grants amounting to \$154.68 million
- Until 2010, ADB focused on secondary cities
- Since 2010, ADB provided assistance to Ulaanbaatar City: MFF- Ulaanbaatar Urban Services and *Ger* Areas Development Investment Program, and TA for Ulaanbaatar Urban Planning Improvement

URBAN DEVELOPMENT: PLANNED APPROACH

- Policy dialogue and capacity building on urban planning and strategic urban development
- Support redevelopment and upgrading of *ger* areas in Ulaanbaatar by implementing the MFF for *ger* areas
- Development of second-tier cities by implementing Darkhan Wastewater Management Project and TA on Darkhan Urban Utility Institutional Improvement Plan
- Carry out National Urban Sector Assessment

EDUCATION, HEALTH, SOCIAL DEVELOPMENT: PAST AND ONGOING ASSISTANCE

- As of 31 December 2014, ADB provided \$226.9 million in loans and grants for the health and social protection sector
- Education sector loans and grants amount to \$119.4 million to support development of TVET sector, curriculum, institutions, and policies
- ADB is a major partner with the government to reform the health and social protection sectors since the 1990s

EDUCATION, HEALTH, SOCIAL DEVELOPMENT: PLANNED APPROACH

- Pre-primary and primary education: School construction, curriculum improvement, and teachers' training
- TVET: supporting practical skills development to meet pressing labor market demands
- PPP in health and primary health care services through franchising
- Enhancement of MIS systems and reforms in social insurance and social assistance
- Develop program on disability (early diagnosis, policy development, capacity building, infrastructure)

PRC: **BRIEF HISTORY** OF ADB OPERATIONS

- 1986 – PRC joined ADB
- 2000 – PRCM opens in Beijing
- OCR grants and loans of around \$33.48 billion from 1986–2014
- PRC made first contribution to ADF and established a poverty reduction and regional cooperation fund in 2005

INNOVATION TO FACILITATE MIDDLE-INCOME TRANSITION

- A strong infrastructure focus on the “western region” for inclusive growth
- A “green portfolio” for environment-friendly and low-carbon development
- Vocational education, elderly care for inclusive urbanization
- Strong linkages with CAREC and GMS, and knowledge sharing

URBAN DEVELOPMENT: PAST AND ONGOING ASSISTANCE

- As of 31 December 2014, ADB provided urban sector loans amounting to \$5.47 billion
- Effective policy dialogue through strategic policy and advisory TAs
- Focus on projects with innovation and strong demonstration and catalytic effects

URBAN DEVELOPMENT: PLANNED APPROACH

- Effective policy dialogue at national level through strategic policy and advisory TAs with strong demonstration effects
- Innovative projects that promote integrated green, competitive and inclusive urban-rural development
- Projects that contribute to regional cooperation, reduce carbon footprint, pollution control, and enhance climate change resilience, and are replicable

EDUCATION, HEALTH, SOCIAL DEVELOPMENT: PAST AND ONGOING ASSISTANCE

- As of 31 December 2014, ADB provided education loans amounting to \$150 million
- Support TVET reforms and Demonstrate innovation in TVET
- Provide TA to develop the health sector, social assistance systems, and human resources needs
- Engage in elderly care and civil society organization's role in service delivery

EDUCATION, HEALTH, SOCIAL DEVELOPMENT: PLANNED APPROACH

- Develop elderly care programming, process first elderly care project
- Continue reforms in TVET and tertiary education to improve quality, relevance and industry participation
- Strengthen quality of teachers at all levels
- Develop targeted programs for social services/education to reduce inequities
- Use innovative financing modalities
