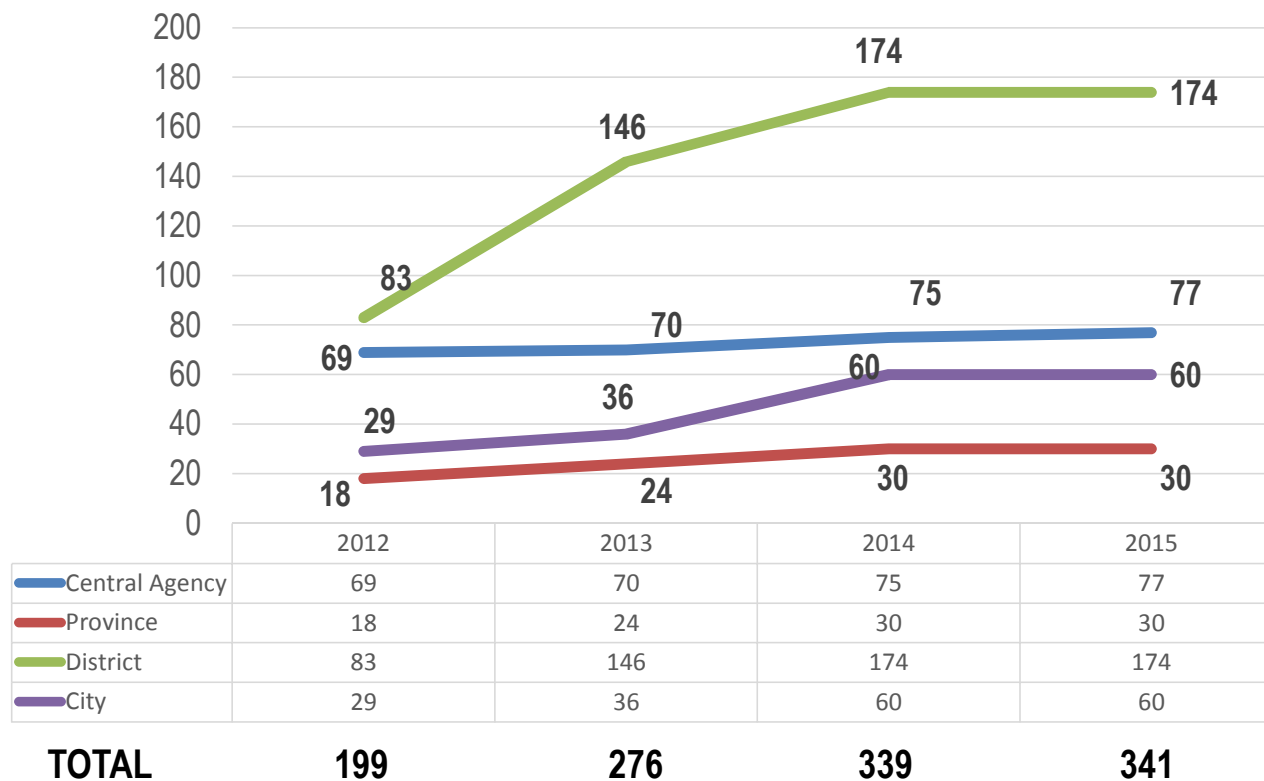

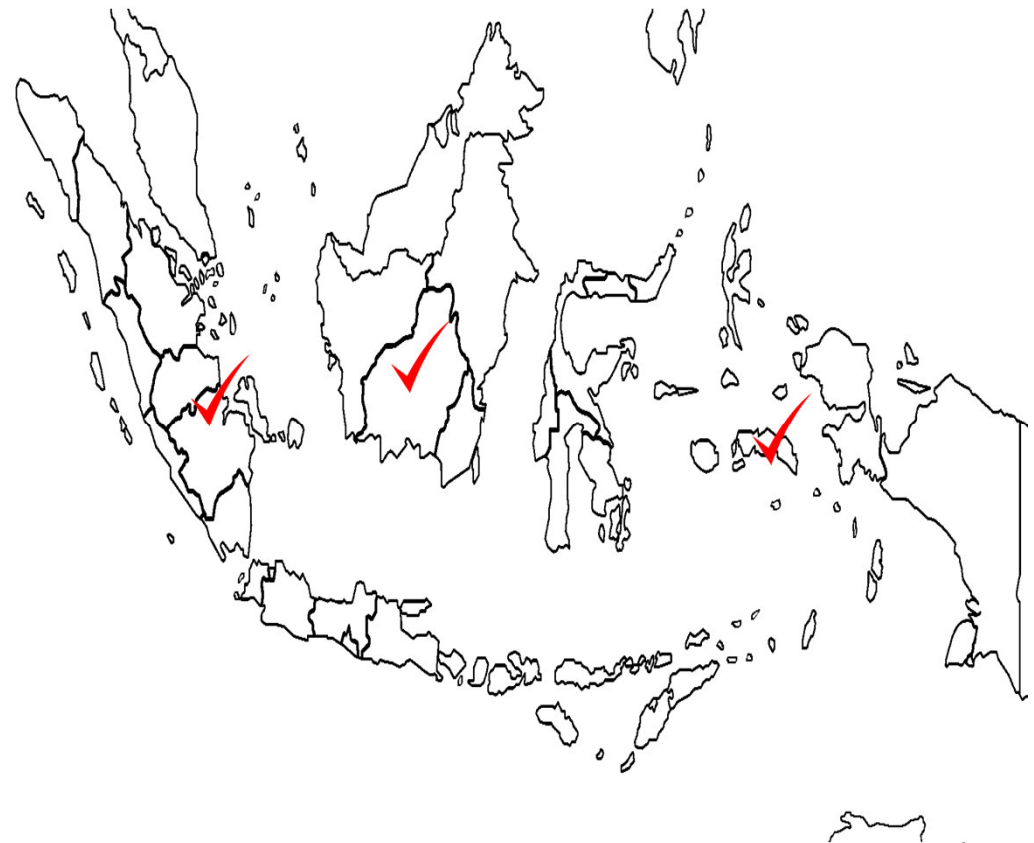

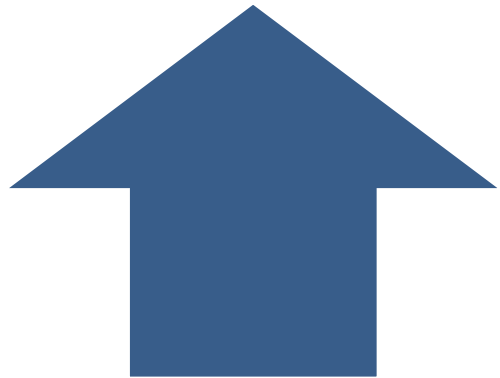

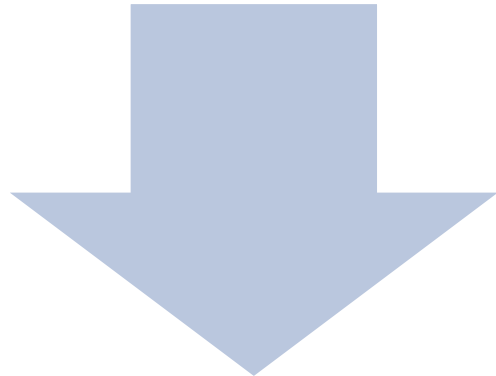


# CONCLUSION
