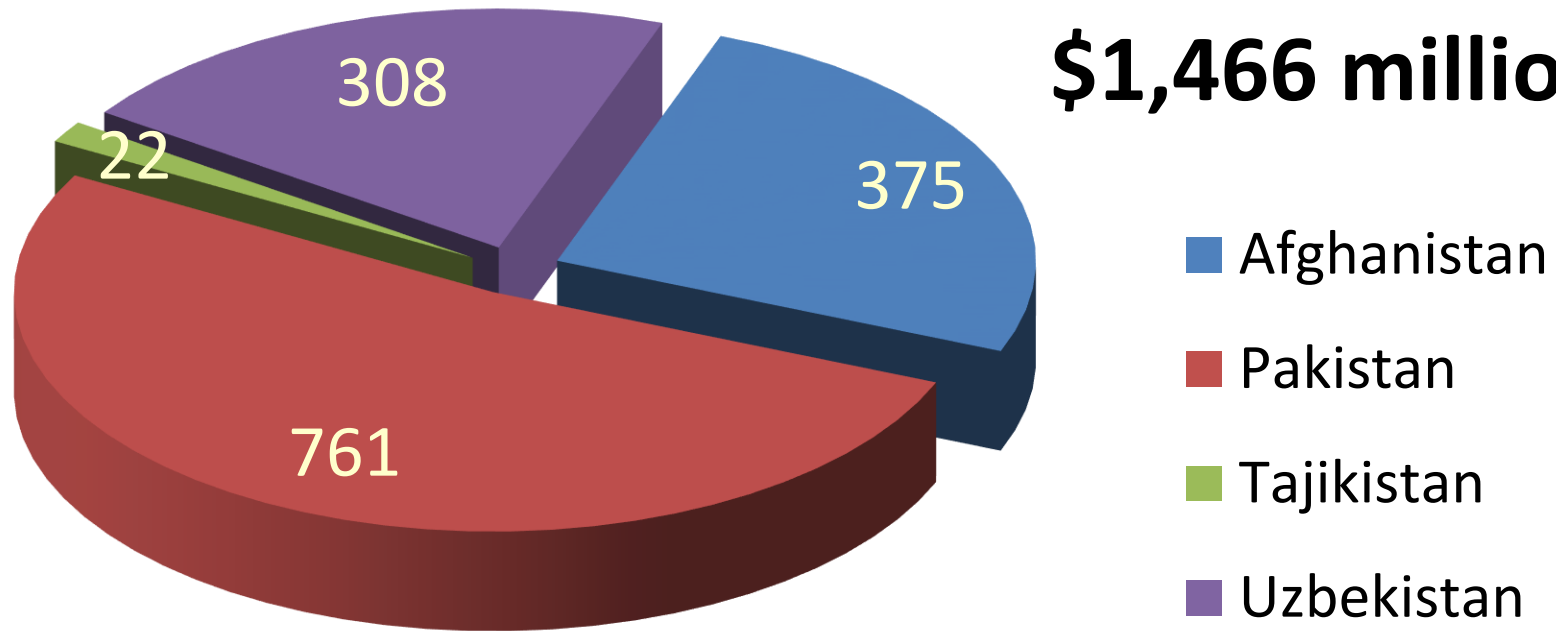

# Ongoing Investment Portfolio (Loan /Grant)

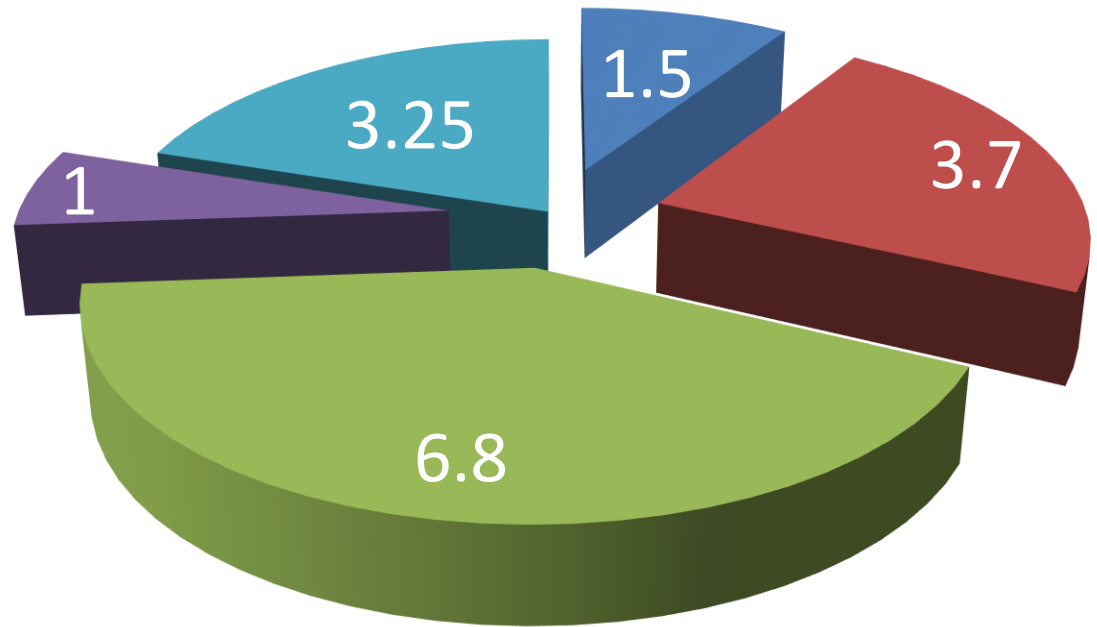

# Lending Pipeline 2016 (1)

## Loan

- TAJ: Water Resources Management in Pyanj River Basin - \$30 million (Expected Approval in June 2016)
- PAK: Pehur High Level Canal Extension Project Loan (formerly Khyber Pakhtunkhwa Water Resources Sector Project) - \$90 million (Expected Approval in June 2016)

# Lending Pipeline 2016 (2)

## Loan

- UZB: Innovations for Agriculture Modernization Project - \$170 million (Expected approval in Nov 2016)
- PAK: Jalalpur Irrigation Project - \$200 million (TBD) (on standby category)

- Enhancing Integrated Water Resources Management in the Aral Sea Basin - \$1 million (Expected Approval in Q3)
- Strengthening SPS measures in the CAREC countries to facilitate trade in the Region - \$ 2 million (Expected Approval in Q3)

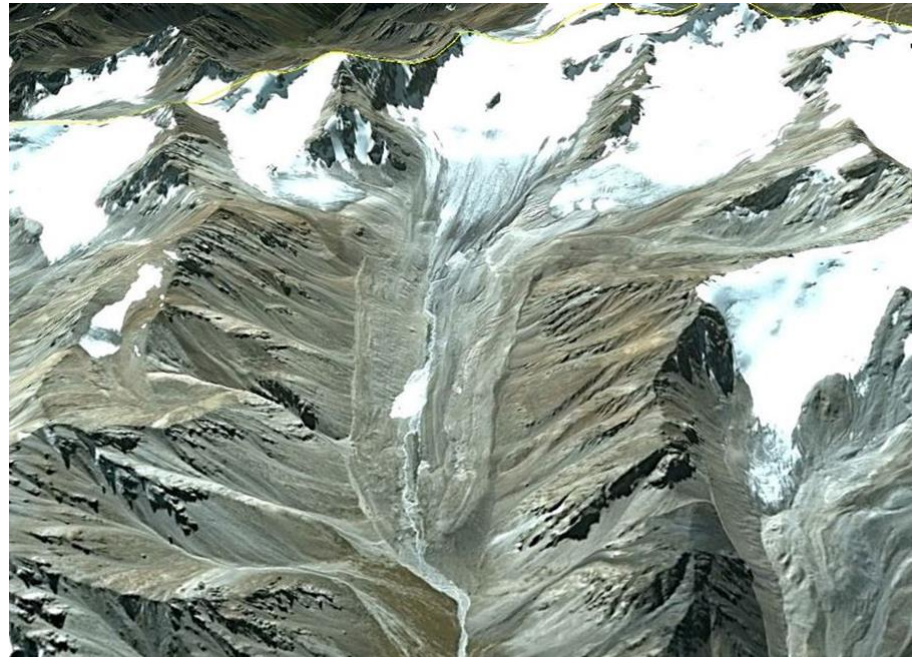
