Building Entrepreneurship and Technology Leadership Skills

- What makes technology startups very exciting?
 - Low capital costs
 - Potential for scale
 - Immediate access to global markets
- What does it take to start a startup?
 - Ability to Build (both technology & business model)
 - Tech skills
 - Financial/Operational Knowledge
 - Ability to Sell (to investors, clients, and hires)
 - Access to Capital
 - Access to Talent



What is the Silicon Valley ecosystem like?

- Strong community
 - Investor ecosystem - Angel investors, venture capital firms
 - Training of startup employees -> founders
 - No expectation of quid pro quo
 - Strong bias towards blogging
 - Risk and failure are understood and embraced
- Standard documents commonly available
 - Incorporation standards like the Delaware C-Corp
 - investment templates like the YCombinator Safe Note
- Heavy involvement by universities
 - Startup fairs for jobs and internships
 - Inviting speakers on campus
 - Intellectual Property Offices
 - Classes around building tech, pitching, marketing



What is the Philippine startup ecosystem like?

- Growing community
 - Few startups where people can learn the ropes
 - Angel investors risk averse (debt rather than equity backed)
 - People use Facebook to share info, e.g. Startup PH
 - Kickstart's investments are going regional
 - Surge in coworking spaces but not at startup-friendly rates
 - Risk-averse and failure-averse culture
 - More mentorship programs
- No standard legal documents
 - Incorporation and employee stock option pool setup is a huge hassle
 - No standard investment templates (leading to founder-unfriendly deals)
- Moderate involvement by universities
 - Startup clubs launching at major universities
 - Some class around technology, pitching, marketing... still geared for corporate employees



What are areas of excitement in Philippine Tech?

- MOOCS and online resources
 - Coursera, Udacity - pick up new tech and startup skillsets
- BPO industry ideally leads to international contacts and next-gen skills
 - Startups focusing on remote work
 - Startups with clients around the world
- Cryptocurrency explosion (PH adopted cryptotech fairly early)
 - Bitcoin all time high of \$15,000
- Culture change
 - A few big winners can seed momentum for the next batch of startups
 - Increase in cultural acceptance of startup/tech jobs
