Operational Program



- **Programmatic approach** aligned with government plans: Yangtze River and Rural Vitalization in the PRC, and Agriculture Masterplan in MON
- Engagement through **policy, knowledge, and investment** support
- Portfolio covers **agricultural and rural development, environmental protection, and natural resources management**
- Investment pipeline of **over \$1.477 billion (2019-2021)**; cofinancing is being sought
- Pipeline will build on existing portfolio

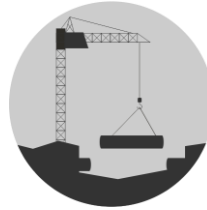

- Ulaanbaatar Community Food Waste Management and Recycling
 - Procurement of composters (**\$1.2m**); OCB (**Q3–Q4 2020**)
- Sustainable Tourism Development
 - Construction of Chinggis Khan Tourism Center (CKTC) building (**\$11.387m**); OCB (**Q4 2021**)
 - Road link construction and sealing (**\$9.575m**); OCB (**Q4 2021**)

Important Considerations



- Collaboration with Local Design Institutes in the PRC
- Domestic processes in the PRC (i.e., domestic FSR, financial validity assessment, foreign capital utilization report, etc.)
- Need to highlight institutional and technological innovation
- Coordinate with local partners due to devolved implementation mode
- Domestic procedures in MON are not well defined and vary from ministry to ministry
