

#### **Meaningful Consultation**

- Begins early in the project preparation stage and is carried out on an ongoing basis throughout the project cycle;
- Timely disclosure of relevant and adequate information that is understandable and readily accessible to affected people;
- Free of intimidation or coercion;
- Gender inclusive and responsive, and tailored to the needs of disadvantaged and vulnerable groups; and
- Enables the incorporation of all relevant views of affected people and other stakeholders into decision making.



#### **Grievance Redress Mechanisms (GRM)**

ADB projects are required to establish a mechanism to receive and facilitate resolution of affected people's (AP) grievances

- Should address affected people's complaints promptly, using a fair and transparent process,
- Needs to be easy to access
- Gender responsive
- Scaled to the risks and impacts of the project
- Can link to (and should not impede) access to the country's judicial or administrative remedies
