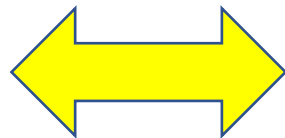
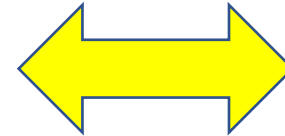

Loan (\$110 million)

- Training on public health care management
- Facilitate coordination between Local Government Department (LGD) and Ministry of Health and Family Welfare MOHFW
- Improved health sector budgeting

- Construction of additional UPHCs
- Continued PPP arrangements for PHC delivery



Grant (\$2 million)

- Training on integrated health approaches; **water/energy conservation and waste management**, climate and disaster response: disease surveillance,
- Reorganization of city government roles to link health determinants i.e., WASH and climate/disasters

- Health Facility site selection – Flood free sites-Climate risk and vulnerability analysis (CRVA)
- Provision of **solar power, energy and water conservation equipment**, and medical equipment

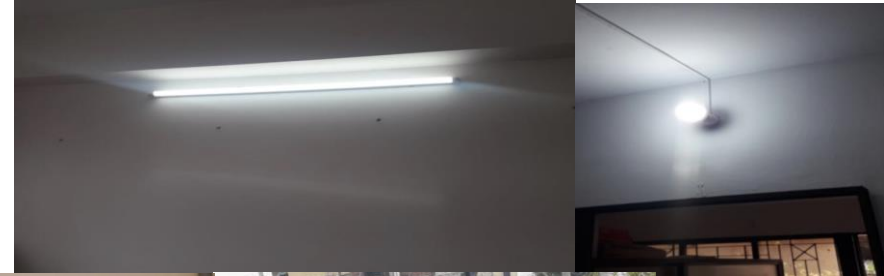

- Hygiene behavior change and communication (awareness campaign)

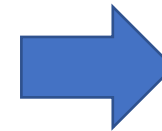
