



# What is Gender Equity and Social Inclusion?

GESI in urban sanitation means:

- a project is designed to benefit everyone in a city or project area, irrespective of their location, gender, social status, or financial capacity.
- A City-Wide Inclusive Sanitation (CWIS) approach means inclusion of population groups that are usually left out.

India (Madhya Pradesh)	Urban Water Supply and Environmental Improv ement Project
Lao PDR	Small Towns Water Supply and Sanitation Sector Project
Nepal	Community-based Water Supply and Sanitation Sector Project



#### India: Urban Water Supply and Environmental Improvement Project, Madhya Pradesh, 2003-2013

**Problem**: Poor households without sanitation; women excluded from decisions

#### Sanitation

- Cost-sharing of household sanitation
- Pro-poor sanitation models
- Rehabilitation of communal toilets, men and women trained in O&M

#### **Institutional Arrangements**

- New staff in implementing agency (community, gender, monitoring, PR)
- Links to slum improvement programs supporting urban poor
- Partnering with NGOs to support participation of poor communities



Lao PDR: Small Towns Water Supply and Sanitation Sector Project, 2009-2016

**Problem:** Women working in water and sanitation sector but not in technical and decision-making roles.

**School-to-work pilot program** for 26 high school graduates

- 4-year university scholarships
- Counsellor for psycho-social support
- Mentoring
- 2-month internships at provincial water and sanitation companies
- Support to get jobs



Nepal: Community-Based Water Supply and Sanitation Sector Project, 2003-2011

**Problem:** Exclusion by gender, caste and ethnicity

- Gender, caste, and ethnicity inclusion strategy for all project components
- Sanitation committees >50% women executive and general membership, representation of poor and caste/ethnic minorities
- Gender-sensitive hygiene awareness campaigns
- Gender and social development specialists in project team
- Sex- and caste-disaggregated data


