


"....most country partnership strategies are not underpinned by systematic and robust climate analysis, leading to weaknesses of ambition, lack of focus, an absence of support for transformational change, and lack of private sector engagement. ADB's current strategic approach lacks sufficient relevance to the rapidly evolving climate context and to the urgent needs of the Asia and Pacific region in future. Countries need ADB to provide support as they transition away from fossil fuels and put in place low-carbon and carbon-resilient economies."

#### **Recommendation 2:**

ADB country partnership strategies and associated programming should be informed by and reflect country-specific climate change diagnostic assessments and should clearly specify the path of engagement and results through both public and private sector operations.

- To strengthen climate change and disaster risk management integration in country programming and dialogues
- Solutions needs to be tailored to country context, aligned with the country's climate and development plans

  - e.g. Joint ADB-WBG Climate Risk Country Profiles, WBG Country Climate and Development Reports
- To support real transformation, a good understanding of issues and drivers relating to CCDRM is necessary early in the process
