

- Unified online procurement portal for all Central and State Ministries, Departments, Bodies & PSEs
- Rule 149 of the GFR amended, mandating the procurement of Goods and Services from GeM for all the Central Ministries and Departments
- Multiple tools enabled for public procurement: Direct purchase, L1, Bid / Reverse Auction, and Forward Auction
- Commitment to Three pillars: Efficiency,
 Transparency & Inclusiveness in public procurement







Growth of buyer organizations on GeM,




Growth of sellers/ service providers on GeM,



Coverage on GeM (as of 30 Nov 2022):












Comparison of "Bid start" to "Bid close" dates of 704 GeM and out-of-GeM transactions; data reported by buyers





Public Procurement: Sustainable Development

- SDG 12:"Ensure sustainable consumption and production patterns".
- ➤ Target 12.7: "Promote public procurement practices that are sustainable, in accordance with national policies and priorities."
- Indicator 12.7.1: "Degree of sustainable public procurement policies and action plan implementation". Incorporating Sustainable Public Procurement (SPP), and the capacity to measure the proportions of these efforts.
- Limitations of this indicator: Different ways the countries measure SPP, Green Public Procurement (GPP) and Socially Responsible Public Procurement (SRPP).
- Sustainable procurement: Purchasing of goods and services to achieve optimal Value for Money (VfM) in delivering positive development outcomes.
- Governments worldwide spend up to 20% of their GDP on public procurement.



GeM: Sustainable Economic Drive

- With an estimated GDP of \$3.53 trillion, India's procurement spending is roughly \$700 billion.
- GeM: A member of 'Task Force on Sustainable Procurement' set up Ministry of Finance (MoF), Government of India with UNEP as an invited expert member.
- ➤ Micro Enterprises: Investment < \$ 125,000 & Turnover < \$ 625,000
- Small Enterprises: Investment < \$ 1.25 Million & Turnover < \$ 6.25 Million</p>
- Boosting MSE participation in government tenders
 - by raising awareness about business opportunities: Encouraging Outsourcing
 - realization of payments: Reserving Funds
 - Single-window registration: API integration with MSE databases for seller auto-registration.



GeM: Sustainable Economic Drive (Contd...)

- Unique features that GeM offers:
 - filtering out non-MSE suppliers while placing orders;
 - seamless integration with treasury and public finance management systems of buyers, which
 ensures placement of orders only after blocking the proposed contract amount; prompt release
 of payment on delivery.
 - Implementation of MSME Order, 2012 of Government of India.
 - More than half of the total orders are placed with MSE suppliers.



Social Inclusion: A Core Value at GeM

- "Access to markets" and "Access to Finance" primary challenges faced by under-served seller groups such as MSEs, women, Divyangjan [persons with disabilities], tribal entrepreneurs, startups, self-help groups, artisan and weavers, and Hunar Haat (Ancestral legacy of arts and crafts)
- Over 130,000 women-led businesses are registered on the GeM; more than 570,000 fulfilled orders totaling \$ 1.34 billion.

Access to markets

- i. Creation of 8 "GeM Outlet Stores".
- ii. Last-mile Outreach and Capacity-building: MoU with Common Service Centre for delivery of GeM buyer and seller services through 0.52 million+ village-level entrepreneurs [VLE], packaging and logistics services through 0.15 million+ India Post Offices.
- iii. Onboarding Cooperative Societies and Panchayats (Village Level Governance)
 - 1. Development of Processes for direct onboarding of Panchayats and Cooperative Societies with \$ 1.25 Billion turnover and A+ audit rating

Access to markets

- v. Artisans & Weavers Since July 2020,
 - a) 11,856 artisans/ sellers fulfilled 9,714 orders worth \$ 5 million from 171 Handicraft product categories
 - b) 8,918 weavers/ sellers have fulfilled 11,856 orders worth \$ 30 million from 27 Handloom product categories.






















GeM: Minimizing Environmental Impact

- ➤ **Green Procurement**: Process to procure goods, services and works with a reduced environmental impact throughout their life cycle when compared otherwise.
- Promoting Green Procurement by targeting and prioritizing the listing and availability of environmentally sustainable products and services.
- Recycling/Reusing Instances through GeM:
 - Making the procurement process digital and paperless: Substantial savings in costs for printing, tender advertising, and travel. Saved up to 550 million paper sheets.
 - GeM is developing "green" products and services categories in partnership with UNEP, TERI & other Indian and global agencies. e.g.,
 - (i) GeM launched Green Air Conditioners, Eco-mark paper (from agro-based and recycled fiber-based raw materials), bamboo-based products, Eco-Friendly Disinfectant (Hydrogen Peroxide + Silver Nitrate)



GeM: Minimizing Environmental Impact (Contd...)

- (ii) Created Filters to help buyers identify solar-powered renewable products and battery-powered e-vehicles.
- (iii) GeM also offers water, energy conservation, audit services, waste management, Hiring of E-vehicles services.
- Recently launched "Green Transition Service" to assist buyers to achieve carbon neutrality and net zero carbon emissions in their operations.
- "Forward Auction": to auction away fully depreciated and/or obsolete assets.
- "Buyback Option": Presently available in 37+ product categories.
