





RF Regulatory Framework




>>> REGULATORY FRAMEWORK




The purpose of the Public Procurement Law is to let procuring entities to acquire the subject matter of procurement of the required quality using the least amount of public funds.









PPD

Department of Public Procurement under the Ministry of Finance of the Kyrgyz Republic



It is a state body of executive power of the Kyrgyz Republic, functioning as a subordinate unit of the Ministry of Finance of the Kyrgyz Republic. The main purpose of the Department is to regulate the public procurement system.



The main functions of the Department:






Web portal of public procurement

(www.zakupki.gov.kg) - the state information system created by the authorized state body on procurement in order to ensure a transparent, accessible and accountable process of public procurement with information retention for at least 10 years







Analytical data on tenders, procuring entities, suppliers, goods, complaints, etc.






Procuring organizations registered on the web portal of public procurement




Supplier/Consultant - (as the context requires) any party or potential party to the procuring entity's procurement procedures

>>> APPEAL PROCEDURE

Suppliers and consultants have the right to file a complaint about all methods of public procurement with the Independent Committee at any stage of the procurement process

Processing of complaints authority and procedure of the processing

For objective review of complaints, the Government of the Kyrgyz Republic establishes the IC involving community representatives, experts, lawyers and certified specialists in public procurement area.

1.The Independent Committee is guided by the Law of the Kyrgyz Republic "On public procurement" and the procedure for electronic public procurement, approved by order of the Ministry of Finance of the Kyrgyz Republic of May 17, 2022.

2. The authorized state body on public procurement shall act as the secretariat of the Independent Committee.

- 4. The Independent Committee considers the complaint in electronic format and within 3 working days makes a written reasoned decision
- measures aimed at satisfying the stated requirements in case of full or partial satisfaction of the complaint.



The Department announces an open competition for inclusion in the independent commission and the reserve.

Members of the independent commission are formed by the Cabinet of Ministers of the Kyrgyz Republic. The members of the independent commission and the reserve are approved for a period of one year.

The web portal evenly and randomly distributes administrative complaints and appeals among members of the independent commission.

The independent committee immediately publishes the decision on the web portal. This decision takes effect from the moment of publication.



To select members of the independent committee and the reserve, as well as to consider reports on the work of members of the independent commission, an Expert Council on Public Procurement is created by order of the Ministry of Finance of the Kyrgyz Republic. Which consists of a number of representatives of the legislative and executive authorities, representatives of the institute of civil society and independent experts.


The independent committee consists of 15 people, representatives of the public, lawyers and specialists with a certificate in public procurement.

Members of an independent committee are personally responsible for the decision made on an administrative complaint or appeal.


The Department performs the functions of the secretariat of the independent commission, provides organizational, documentary and technical support for the activities of the independent commission. If necessary, an independent commission may make a request to other government bodies, these requests are sent through the Department.




IC's decision on complaints **Total number- 1905**



Violation of the legislation in the field of public procurement by officials of the procuring organization, members of the tender commission or employees of the procurement department of the procuring organization in carrying out procurement procedures, if these actions do not contain signs of actions for which criminal liability is provided.
