- Based on best practices, principle-based, time-tested
- Harmonized with other Multilateral Development Banks


The use of ADB Procurement Framework is expected to








#### Challenges in Applying ADB Procurement Framework

How to manage multiple procurement frameworks:

- Additional resources and efforts for training, staffing, system development (e-GP).
- Dealing with differing provisions, practices, approaches.
- Managing multiple stakeholders (decision makers, auditors, bidders, legal-, integrity-, and civil organizations, press, etc.)

Lack of understanding can cause delays, mistakes, unsuccessful procurement.



#### **Differing Provisions, Practices and Approaches**



- The use of standard unit rates, specifications, and price adjustment that may exhibit gaps when compared to the market conditions.
- Rejection of bids that fall below or exceed the cost-estimate by certain margin.
- Tender with a single bid received tends to be cancelled.
- What constitute as material deviations that can lead to rejection of bid.

#### **Dispute Avoidance Mechanism in the Contract**



- Recurrent delays in setting up a Dispute Adjudicator Board.
- Availability of local expertise in dispute adjudicator.
- Delays in implementing of engineer's determination or DAB's decision.





#### **Professionalization of Project Implementation Functions**

- The scope, scale, and complexities of contracts under ADB-financed projects will benefit from professionalization of procurement, contract management, and dispute adjudicator functions.
- There are growing needs to develop pools of experts of these functions from both the government and private sectors.
- Supports from loan consultant could supplement but should not replace institutional capacity.
- Development of advance study and certification on public procurement, construction law, construction contracts, contract management, and dispute adjudication is key.





# **Going Forward**

- Better utilization of Strategic Procurement Planning (SPP) process
  - Assessment of procurement capacity and supply market
  - Lessons-learned to mitigate risks and preempt issues
  - Apply fit-for-purpose approach to maximize Value for Money (VfM)
  - SPP is a living document: for reference and updates during project implementation
- Establish a systematic and sustainable capacity building program
  - Promote networking, experiences sharing, peer learning
  - Build pool of certified experts
- Expand stakeholder communication
  - Reach out to wider audience (auditors, legal-, integrity-, and civil organizations, business communities/associations, press, etc.)





### Recommendation

- Inter-agency coordination, clarification, and trainings to encourage setting up an effective dispute resolution mechanism, and to acceptance/implementation of its determinations/decisions.
- Facilitate development of pool of experts from within the government and private sectors – a list of certified adjudicators
- Facilitate development of advance study and certification on public procurement, construction law, construction contracts, and adjudication.
