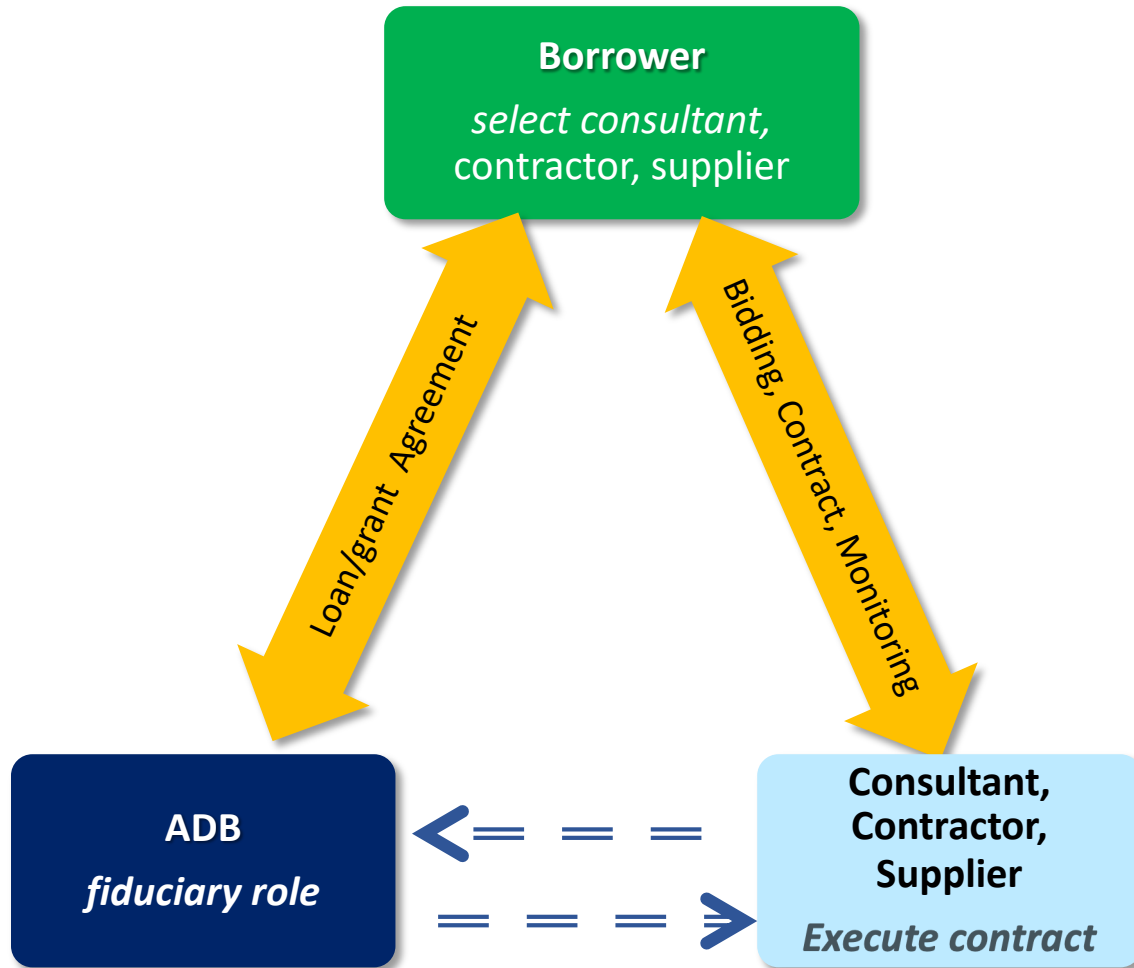

Roles and Responsibilities in ADB Procurement-Loan/Grant



- Borrower (EA/IA) carries out bidding of goods and works and selection of consultants*
- Borrower signs contract and monitors contract execution
- ADB reviews the procurement process to ensure compliance with the Loan/Grant Agreement.
- ADB may receive complaints and audit/sanction contractors.

* **Exception:** ADB may select consultants on behalf of borrower.

ADB Procurement Framework

- All procurement under loan/grant shall be subject to ADB Procurement Policy and Procurement Regulations for ADB Borrowers.
- 6 principles under ADB procurement :
 - ✓ Fairness
 - ✓ Economy
 - ✓ Efficiency
 - ✓ Transparency
 - ✓ Quality
 - ✓ Value for Money

ADB Procurement Methods

<Goods, Works, Non-consulting services>

- Open Competitive Bidding
- ✓ International Advertisement
- ✓ National Advertisement

- Limited Competitive Bidding

- Request for Quotation

- Direct Contracting

Use of E-GP system

- “ADB encourages borrowers to continually modernize their procurement systems including procurement through electronic means (e-procurement).”
- ADB needs to verify the compliance to the requirements: fairness, safety, etc
- ADB agrees with MOF to use the system for RfQ - Goods in 2022

ADB Anticorruption Policy

- Applies to EAs, contractors, consultants, suppliers, ADB staff, and anyone connected to an ADB-financed, -administered, or –supported activity.
- Prohibited Activities: corrupt, fraudulent, collusive, coercive, or obstructive practices
- Will be subject to Sanction List
- Contractors agrees ADB's right to audit its bank account etc.

ADB Member Country Eligibility

- All services and goods must be procured from ADB Member Countries
- Exceptions :
 - (1) In case of some co-financing operations
 - (2) Waive by the Board of Directors – **COVID-19 Response Projects**

Debriefing and Complaints

Debriefing:

- Unsuccessful bidders may request debriefing from the procuring entity (the EA or ADB). If they are not satisfied with the explanation given, they may submit a complaint.
