

Operations in the Pacific







Issues/Challenges



- □ Weak capacity of implementing agencies due to lack of staff or high staff turnover
- Low government ownership which contributes to delays, particularly in ADF countries
- □ Price escalation has been a huge issue in the last few years due to the cost of freight
- Limited bidders. Countries are remote and the value of packages is comparatively small
- Slow procurement and consultant recruitment (national consultant recruitment is particularly difficult)
- □ Land acquisition can be an issue since many countries have communally-owned land
- Financial management issue (e.g., delayed APFS submissions) is apparent for many Pacific
 DMCs–frequently affecting all ADB projects in the region



Other Issues/Challenges



- □ Weak contract management and procurement-related issues
- Poor performance/quality of contractors and consultants
- Systemic delays to projects due to government administrative actions/processes
 contributing to prolonged procurement process and delays in the overall project
 implementation
- Low project readiness of most projects requiring an extension of the project implementation period
