### WUS Sector Projects Readiness Issues and Challenges in 2017-2019

- Absence or poor quality of Government feasibility studies;
- Absence of detailed design, project management, construction supervision consultants (development of TOR/cost estimates, selection process, review/approval of procurement decisions by Government Procurement Committee usually started after ADB project approval)
- Absence of technical specifications, bill of quantities, drawings, estimated amounts etc. for procurement of goods and works, as usually these documents are prepared by or with the support of detailed design, project management, construction supervision consultants
- No advance contracting or retroactive financing due to financial constraints
- Prolonged procurement process and procurement decision making
- High staff turnover at EA (then Agency Uzkommunxizmat)
