

National Polices & Strategies on Public Procurement & e-Procurement

> No Dedicated Policies and Strategies on Public Procurement & e-Procurement

Policies and Programs (F.Y. 2024/25)

✓ The procurement law will be reviewed to make the procurement system competitive, transparent and development-friendly. Institutional capacity of procurement units of public entities will be enhanced. (Unofficial Translation)

Budget Speech (F.Y. 2024/25)

- ✓ The procurement process will be made simpler, more transparent, and cost-effective by developing separate criteria according to the nature of goods and services. If all the bid proposals exceed the cost estimate, arrangements will be made to negotiate the contract with the lowest bidder without changing the terms of the contract. (Unofficial Translation)
- ✓ An e-market portal will be developed to allow the direct purchase of listed goods and services through negotiation. The public procurement law will be amended to include provisions such as selecting qualified bidders through reverse auction in the procurement information system for purchases up to a specified price limit where qualification evaluation is not required. (Unofficial Translation)



Current Status & Perspectives on e-Procurement

Organizational Structure



- Public Procurement Monitoring Office (PPMO) is the apex body, responsible for monitoring overall public procurement.
- PPMO is placed under the Office of the Prime Minister and Council of Ministers (OPMCM), headed by the Secretary.
- > There are a total of 46 positions for staff in the PPMO.
- ➤ Total 5 IT Personnel in PPMO.
- > Operation, Enhancement & Maintenance of eGP System by Consultant.

> Key Functions of Public Procurement Monitoring Office (PPMO):

- Prepare public procurement policy, monitor the public procurement law implementation
- Establish and maintain Electronic Government Procurement system (e-GP)
- Develop and Issue Standard Bidding Documents, manuals, directives, guidelines, instructions, technical notes for facilitating the procurement proceeding.
- Make arrangements for regular training for the bidders and employees, etc.



Around 60 % (Unofficial Data) of the annual national budget has been allocated for public procurement, out of which:




Size of e-Procurement



Coverage of e-Procurement (e-GP Directive Provision):

- > Open bidding should be done through the eGP system only.
- Other procurement methods, like Sealed Quotations and Direct Procurement, may also be done through the eGP system.
- Generally, values greater than Nrs. 2 million should be procured under open bidding competition.

No. of Bids Published through eGP System Phase II



Challenges & Issues on e-Procurement

Major Challenges



- ICT Infrastructure: Most of the infrastructure used in e-GP system are in End of Life and End of Service status. There is the urgent need to upgrade existing infrastructure.
- Human Resource: Currently, PPMO is facing insufficient number of IT personnel. There are concerns about the availability of trained personnel to effectively operate and maintain the e-GP system, which could hinder its full implementation
- Software Technology Stack used in e-GP System.
- Credibility and Security of e-GP System.
- Capacity Building of Stakeholder.
- Development of full fledge e-GP System: Integration of system with other related agency, Payment module etc.
- Creation of different Template in system according to SBD.
