- Improve governance and institutional capacities of cities





Changing the Urban Development Narrative in Pakistan

Historically, urban development in Pakistan has been characterized by ad hoc and fragmented investments, lacking a cohesive long-term vision. To address this, the ADB Urban team is collaborating with the Government of Pakistan to promote a more sustainable development approach through integrated planning and institutional reforms. ADB's urban projects in Pakistan incorporate the following aspects:

Facilitate discussion on the need to transform urban governance.

Foster the realization that urban development requires thorough understanding and long term, integrated planning.

Improve financial and operational sustainability of investments through up-front planning.

Develop collaborative form of governance, like public-private-partnerships.

Establish that data-driven scientific and technological approaches are the answer to redefining rules of accountability and resolution of urban problems.

Ensure that social and environmental safeguards receive the attention and priority they warrant.
