

# 2021 UNESCO Recommendation on the Ethics of Al



# ELEMENTS OF THE IMPLEMENTATION STRATEGY

- 1. Capacity-building and monitoring tools:
  - Readiness Assessment Methodology
  - Ethical Impact Assessment
- 2. Al Experts Without Borders: a roster of experts managed by UNESCO for deployment in beneficiary countries for targeted capacity-building interventions
- 3. Women for Ethical AI Network (W4ethicalAI) to spearhead the implementation and deployment of the Recommendation from gender perspective
- 4. Global Forum on Ethics of AI as an annual high-level flagship event
- 5. Observatory of AI Ethics to gather state of the art analysis around the world on ethical AI
