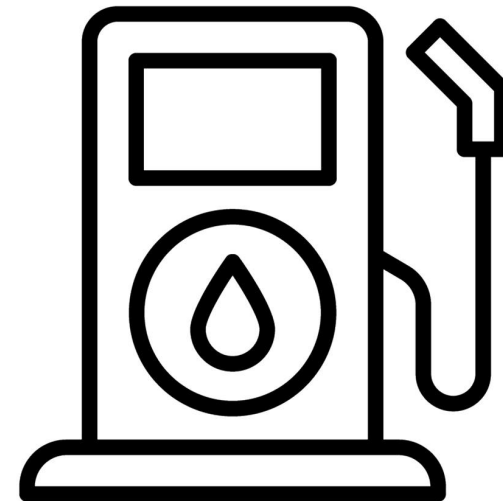

State parties to provide incentives for the private sector to adopt integrity measures to prevent and combat corruption.

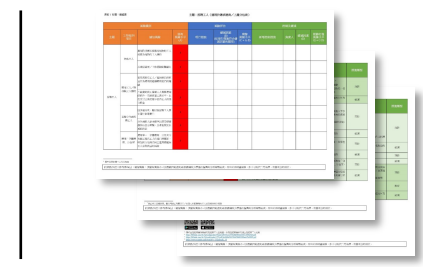

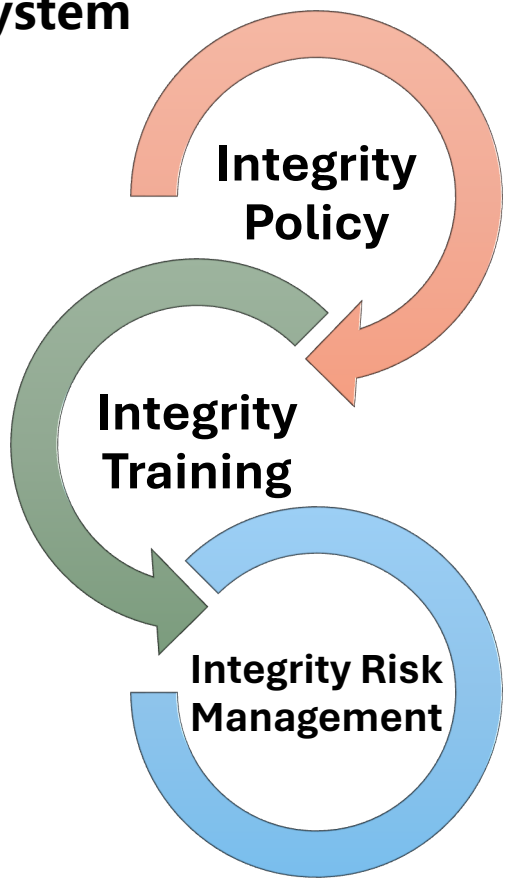
