

Disbursements from 2019 to June 2024 (\$ million)





AZERBAIJAN:

Railways Digital Transformation Project

Total Amount: \$47 million

ADB: \$47 million

Approval: September 2024 Commitment: October 2024

Project Description:

This project will support the digitalization of key processes at the Azerbaijan Railways (ADY) Closed Joint Stock Company, including cargo operation management, asset management, investment and construction management, the cargo commercial system, and corporate functions. The project will improve ADY's operational and financial performance through streamlined data management, optimized asset management and overall rail operations, reduced cost, enhanced rail safety, and better workforce efficiency.







2025 Kazakhstan:

KTZ Darbaza-Maktaaral Railway Expansion Project

Up to \$270 million (equivalent in Japanese Yen) senior unsecured loan to fund the construction of a new 152 km railway line in the southern region of Kazakhstan. The project is essential for the development of railway infrastructure to support increasing freight flows to Central Asia as the existing infrastructure on the border with Uzbekistan has reached its maximum capacity. IFC and AIIB are expected to cofinance the project with up to \$135 million each in CHF or JPY. The borrower, Kazakhstan Temir Zholy National Company JSC (KTZ), is a transport and logistics holding company operating in Kazakhstan and internationally. The company was founded in 1997 and is based in Astana. The company operates through two segments, freight transportation and passenger transportation.

Kazakhstan holds a strategic position as a land bridge between Asia, Europe, and the Middle East. The country links the large markets of the People's Republic of China (PRC), South Asia, and Western Europe by road, rail, and ports on the Caspian Sea. The proposed project provides a great opportunity for ADB to support Kazakhstan in modernizing its transport corridors. The construction of a new railway line will allow redirecting cargo from the existing Saryagash-Tashkent section and increasing export traffic to Uzbekistan. Cargo going to Afghanistan, Iran, Tajikistan and Uzbekistan will move faster along this line. The project is fully aligned with the CAREC Transport Strategy 2030 and Railway Strategy for CAREC 2017–2030, particularly with (i) cross-border transport and logistics pillar and (ii) railways pillar.

Project Description:

The proposed project includes four components: 1) construction and upgrading of three inland waterway ports (Hefei Paihe Port, Lu'an Port, and Wuhu Sanshan Port); 2) demonstration of inland waterway green shipping through the development of the Hefei-Wuhu clean energy container shipping route; 3) promoting new technology for ports and shipping, focusing on energy-saving and emission-reduction loading and unloading equipment, advancing automated wharfs, establishing a comprehensive port energy system, promoting shore power-supply technology, prevention and control of port pollution, strengthening resource conservation and ecological protection, and promoting research and development; and 4) institutional capacity building mainly on green and smart ports and shipping.

Project Description:

The project aims to improve Fiji's rural and urban transport connectivity by replacing key bridges that are essential to domestic transport network. Addressing the operations and maintenance capacity issues of the Fiji Road Authority, the project will provide capacity building to inspect and maintain the bridges.







2024 India:

JBM Haryana Electric Bus Financing Project

Up to ₹3,005.0 million (equivalent to \$36.0 million) to partly fund the procurement, operation, and maintenance of 450 electric buses (e-buses) and associated depot and charging infrastructure in the state of Haryana, India. The project is a PPP between JBM and the Directorate of State Transport, Haryana, a department in the Government of Haryana will be the public sector partner. The project serves to modernize the state's public transportation system with a focus on environmental sustainability by deploying an e-bus fleet

ADB will bridge a critical financial gap for JBM Group in the e-bus business by providing long-term financing in local currency. The project is categorized as Gender Equity Theme and is consistent with several elements of ADB's Sustainable Transport Initiative: scaling up urban transport, assisting in developing climate change and energy-efficient solutions, and supporting road safety and social sustainability.



- Provide additional capacity building support to the PPP Authority and the Roads and Highways Department.

Project Description:

The project aims to upgrade the 87-km Joydebpur–Mymensingh highway, part of National Highway-3, which connects six districts and 10 special economic zones. This initiative mirrors Bangladesh's success in attracting international investments through road sector PPPs. This project is a Government-to-Government PPP in collaboration with the Republic of Korea. ADB is considering climate change measures such as solar panel installation along the corridor ("green corridor project").

Permanent road link between the provinces of Bataan and Cavite, the key missing link in the road network of the National Capital Region, Central Luzon, and Calabarzon.

Inclusion of a tourist centre to provide information about the rich ecosystem and diversity of destinations on the Bataan Peninsula and Corregidor Island.

Project Description:

Expansion of the mass rapid transit (MRT) network in the Jakarta Metropolitan Area (JMA). It will support the development of the Jakarta MRT East-West Line – Phase 1 Stage 1, for about 25 km along the major east-west corridor in Jakarta. The new East-West Line will be connected with the existing MRT North-South Line and other mass transit systems operating in the JMA.

PHI: Metro Manila Bridges Project (Loan 4168): 3 civil works packages (\$133M total); 1 consulting services package to cost \$1M.

PHI: Manila Metro Rail Transit Line 4 Project: 3 early works packages (\$10M total); 4 civil works (\$750M); 1 consulting services package (\$60M); and 2 railway systems and trains (\$550M total).

THA: Climate Resilient Connectivity for the Eastern Economic Corridor Project (M7): civil works package to upgrade/extend of existing roads (\$100M total); 1 consulting services package (\$4M).

TIM: Proposed East to South Coast Road Connectivity Project: One civil works package to cost \$45M; 1 consulting services package to cost \$6M.
