

Pandemic Response and Preparedness



Strengthening Health Supply Chains, Vaccine, Pharmaceutical, Diagnostic Availability

- Severe shortages observed for vaccine manufacturing (Vaccine, Pharmaceutical and Diagnostics - VTD)
- Demand and political will for expanding domestic VTD capacity within the relevant DMCs



Regulatory Strengthening (Vaccines, Pharmaceuticals, Medical devices)

- Weak Regulatory capacity leads to external dependence for the supply – WHO Listed Authorities (WLA)
- Requirement: Regional Harmonization, Reliance and Cooperation – Public Good Regulatory standards



One Health Approach including Animal Health

- Recent outbreaks such as COVID-19, bird flu (H5N1) and calamities such as earthquakes and wildfires highlight the interdependence of human health on animals and environment
- Challenges such as coordination, governance, limited surveillance, inadequate IT system persists



Strengthening Human Resources Capacity, Governance and Centers for Disease Control and Prevention (CDC)

- Coordinator, facilitator, and mentor institution
- "Functional umbrella" to all health care, and public health departments


