How Do We Think of Civil Society?

The term "civil society organization" refers generically to organizations

not based in government, and not created to earn profit

ADB defines CSOs as nonprofit organizations independent from the government, which operate around common interests. They vary in size, interests, and function, and include nongovernment organizations (NGOs), youth groups, community-based organizations, independent academic and research institutes, professional associations, foundations, faith-based organizations, people's organizations, and labor unions. CSOs represent interests of their members or others.

Provides institution-wide support to ADB engagement with civil society organizations


2 Supports ADB responses to civil society advocacy and policy and project concerns




ADB Governance Structure





Technical Assistance

- Small institutional pool (\$250M in 2022)
- Mostly used for innovative pilot projects
- Selection overseen by ADB
- Consultant Management System

Sovereign Loans

- Large institutional pool (\$20 Billion in 2022)
- Selection overseen by the government
- ADB assists with project design so
 CSOs need to be built into the very early stages of the project vision
- **Government Procurement Systems**

Consulting Services

Project Preparation and Implementation, Site supervision, detailed design, knowledge products, policy/advisory

Non-Consulting Services

Surveys, Training, Translation, Event Management

Turnkey Contracts

Powerplants, pump stations, water plants, airports, etc.

Civil Works

Roads, Bridges, Railways, Irrigation Canals, Schools, etc.

Supply of Goods

Machinery, Equipment, Furniture, Computers
