





Framework (2006); not a party to the Cross A party to the Uniform European Investment Bank Debarment Agreement.







Integrity Violations – Example 1

- Lead firm in Joint Venture misrepresented partner's engagement
- Lead firm made false statements •
- Lead firm failed to respond to OAI's findings
- **Result** 6-year sanction for lead firm and its director



Integrity Violations – Example 2

- Firm and authorized representatives submitted bids for two ADB contracts while under Sanction for fraudulent practice
- Result 3 additional years published sanction for firm and representatives



Violation of sanctions



Integrity Violations – Example 3

- Winning firm owned by Implementing Agency Officer
- Competing firms colluded to defraud ADB with false bids
- Result 7-year sanction for 2 firms and 3 individuals




