

- Work & Business Permits
- Local Rules and Regulations
- Very Strong Safeguards requirement





KEY LEARNING: RIGID BIDDING AND CONTRACTING CONDITIONS



- Prequalification criteria are rigid and non conforming bids are thrown out
- Current Move to Merit based scoring may assist companies with strong reputations and system
- ADB & World Bank Payments –
- Large Bureaucracies founded around standard Processes
- Difficult projects requiring planning and attention to methodology
- Business Support
 – EFA, ANZ, Austrade,
 Pacific-based industry associations


