

Bangladesh and ADB

- Bangladesh became ADB member in 1973
- Bangladesh Resident Mission established in 1982
 - first field office of ADB



ADB has committed 726 public sector loans, grants, and technical assistance totaling \$31.8 billion to Bangladesh.





ADB Overall Portfolio in 2023 was \$116.7 billion





Portfolio Growth Over Last 10 Years




