



Identify Key ESG Factors

Determine the most relevant ESG factors for your specific industry and procurement needs

Develop a Rating System

Assign weights to different ESG factors based on their importance.

Standardize the scoring criteria so that all suppliers are evaluated on an equal basis.

Evaluate Suppliers

Collect data on supplier performance, including ESG reports, certifications, and self-assessments.

Ask suppliers to fill out ESG questionnaires and evaluate their responses.

Ethical Conduct - Adhere to ethical business practices, including anti-corruption and anti-bribery measures.

Transparency - Disclose relevant information about operations and supply chain.

Product Categorization

Create specific facets for sustainable products, such as "eco-friendly," "fair trade," or "recycled."

Sustainability Badges

Use visual cues like badges or labels to quickly identify sustainable products.

Product Durability and Longevity

Product Lifespan - Highlight products designed to last, reducing the need for frequent replacements.

Buyers describe the ESG activities, obligations and performance standards that the Contractor must adhere to, which also become legally binding as they are included in the contract.






